Sub: - Monthly progress report in connection with Census - 2011

Sir,

1. The Houselisting Operations (HLO) phase of field work i.e. data collection for the Houselisting and Housing Census schedules and for the National Population Register (NPR). Households' schedule is completed in Banderdewa circle of Capital Complex. In Itanagar & Naharlagun, few enumerators were given 2-3 EBs by Census department. In respect of those EBs, work is going on at maximum speed. Matter is briefed to DCO, Shillong & they have advised us to continue the work & complete it at the earliest.
2. The completed schedules are at scrutiny stage in the hand of the Supervisors under the guidance of Charge Officers of the respective circles and Census Officers from the DCO, Shillong.
3. The Supervisor have been asked to take great care of the survey schedules because for proper scanning of these schedules these are to be preserved with great care at all the stages.
4. The Supervisors of each circle have been asked to scrutinize the schedules thoroughly so as to rectify all types of errors and omissions on the part of the enumerators. They have been asked to submit the scrutinize schedules to the respective Charge Officers without making any delay.
5. It has been reported by the Charge Officer as most of the villages and urban blocks have natural boundary and without any specific point for demarcation, proper care has been taken to avoid over lapping or omission of any households.
6. The four digitd list of the villages which has been supplied by the DCO, Shillong has been fully covered in all the three circles.
7. Wide publicity has been given to the general public thorough newspaper also, so as to ensure that not a single person remain outside the coverage of Census activity at any corner of these three circles.
8. A Grievances Cell-cum- Control room has been jointly constituted for whole Papum Pare District in the office of the Deputy Commissioner, Itanagar Capital Complex, Naharlagun in order to redress any grievances/complaints from the public or from any other sources.
