NOTIFICATION

The Governor of Arunachal Pradesh is pleased to approve the revision of existing trade licence fees and inclusion of more new trade items for streamlining of trade fees as per Cabinet decision taken on 5th June,2008 vide No. CAB/M-06/2008 item No.17. The revised rate of initial fees and yearly renewal fees on each trade items are shown in Annexure 'A'. A penalty for late renewal shall be realized @ 0.5% of the initial fee per day from the defaulters. The revised rate will be effective from the date of issue of this order.

This supercedes earlier order No. GA (A)-Tax. 30/81 (pt) dated 10/05/1990.


