Whereas, the Government of India, Ministry of Tribal Affairs, New Delhi vide their letter No.1, No.15025/2/2013-C&LM dated 30th April, 2015 and letter No. 16014/09/2015-C & LM-I dated 8th March, 2016 informed the Government of Arunachal Pradesh that any notification under Article 342(2) of the Constitution of India can be issued only after an Act of Parliament and as such the Notification No. Secy.(SW)/SC/ST (IN-EX-99) Pt-II dated 6th February, 2015 notified 'Yobin Tribe' as Scheduled Tribes of Arunachal Pradesh is not in accordance with the provision of the Constitution of India, hence, it is to be withdrawn/cancelled/rescinded.

Whereas, the department of Social Justice Empowerment and Tribal Affairs, Government of Arunachal Pradesh accordingly examined the proposal in detail and with the prior approval of the Government, the above matter was placed again before the State Cabinet on 4th January, 2017 for decision and approval for withdrawal/cancellation of Notification No. Secy. (SW)/SC/ST(IN-EX-99) Pt-II dated 6th February, 2015 notifying 'Yobin Tribe' as Scheduled Tribes of Arunachal Pradesh.

Whereas, the State Cabinet in its meeting held on 4th January, 2017 had approved for cancellation of the aforesaid Notification No. Secy. (SW)/SC/ST(IN-EX-99) Pt-II dated 6th February, 2015 regarding 'Yobin Tribe' as Scheduled Tribes of Arunachal Pradesh.

Now therefore, the Governor of Arunachal Pradesh is pleased to rescind/withdraw/cancel the Notification No. Secy. Subject : **Timely and regular conduct of Departmental Promotion Committee (D.P.C.) meetings.**

No.AR-54/2016.— It has come to the notice of the Government that many Departments are not convening the periodical Departmental Promotion Committee (DPC) Meeting thereby depriving timely promotion to the eligible Officers/Officials and forcing many Officers/Officials to stagnate inordinately at a particular post for years together despite being eligible for promotion.

2. Such stagnation in service has a cascading effect in the Departmental hierarchy which adversely affects the morale of the Officers/Officials resulting in low work output and degradation of overall work culture in the Department. It has been noticed that, non-conduct of timely DPC meetings has also become major cause of corruption in the Departments. There are many instances where officers and officials are left with no other option but to resort to unfair means and approaches in getting their promotion cases considered either through an induced sitting of DPC or without any DPC at all.

3. The Government has taken a very serious view in respect of this matter. It has been felt that in order to have maximum work output from the Government employees, better career progression and more congenial working atmosphere has to be ensured.

4. In view of the above, all the Principal Secretaries/Commissioners/Secretaries/Heads of Departments (HoDs)/Heads of Office (OOs) are directed **to conduct the Departmental Promotion Committee (DPC) meeting at least once in six months as indicated below :-**

- (i) **Departmental Promotion Committee (DPC) Meeting shall be held for promotion of Officers/Officials who come under the zone of consideration during the month of January to June - the first week of July of the particular year.**
- (ii) **Departmental Promotion Committee (DPC) Meeting shall be held for promotion of Officers/Officials who come under the zone of consideration during the month of July to December - the first week of January of the succeeding year.**

5. The above decision is brought to the notice of all Heads of Departments/Appointing Authorities/organizations' under the Government of Arunachal Pradesh for strict compliance. The Action Taken Report (ATR) of the six-monthly Departmental Promotion Committee (DPC) Meeting should be submitted to the Department of Administrative Reforms without fail for record purposes.
