OFFICE MEMORANDUM

The 7th February, 2017

Subject : Communication from State Government to Union Ministers.

No. AR-06/2017.—Instances have come to notice where communication to Union Ministers from the State Government has been addressed by officers of the State Government. This is not in accordance with established protocol and has become a matter of embarrassment to both the Government of India and the Government of Arunachal Pradesh.

In this connection attention is drawn to para 3(ii) of Chapter 6 of the Central Secretariat Manual of Office Procedure which lays down the protocol for addressing such communication to Union Ministers which is reproduced below :-

“Where a communication is addressed to a Minister, it shall, as far as possible, be replied to by the Minister himself. In other cases, a reply should normally be signed by an officer of the rank of Secretary only.” (This procedure relates to Union Ministers and Secretary to the Government of India).

As far as the State Government is concerned, where a communication is to be addressed to a Union Minister, it shall, as far as possible, be replied to by the Chief Minister only. In exceptional cases, where the matter is very urgent and Chief Minister is not available due to some unforeseen circumstances the reply should be shown to the Chief Minister through FAX/Whatsapp and obtain the approval. This may be signed by a Minister or Chief Secretary to the Government of Arunachal Pradesh stating that the same has the approval of the Chief Minister.

This is for strict compliance and any lapses in this regard will be viewed very seriously.

1. Short title and commencement : 1. These rules may be called the Arunachal Pradesh Right to Information (8th amendment) Rules, 2017.

2. They shall come into force on the date of their publication in the Official Gazette.

2. Amendment : In the Arunachal Pradesh Right to Information Rules, 2005 (hereafter referred to as Principal Rules) for Rule 8 the following shall be substituted, namely :-

“8 (1) A request for obtaining information under sub-Section (1) of Section 6 of the RTI Act, 2005 shall be accompanied by an application fee of ` 10 (Rupees ten) by way of Demand Draft/Indian Postal Order (IPO)/Bankers Cheque/Treasury Challan payable to the Accounts Officer of the Public Authority.

- (2) For providing information under sub-section (1) of Section 7 of the Right to Information Act, 2005, the fee/cost of material shall be charged by way of Demand Draft/Indian Postal Order (IPO)/ Bankers Cheque/Treasury Challan payable to the Accounts Officer of the Public Authority at the following rate (s) :-
- (a) Information relating to tender documents/Bids/quotation/Business contracts : minimum ` 500 (Rupees five hundred) up to 250 pages and thereafter ` 2 (rupees two) for each additional page(s).
- (b) A-4 or A-3 size paper created or copied : ` 2 (rupees two) per page.
- (c) Large size paper : actual cost/price so fixed.
- (d) For inspection of recods : no fee for the first hour and a fees of rupees five for each fifteen minutes (or fraction thereof) thereafter.
- (e) Samples or models : Actual cost
- (3) For providing information under sub-section (5) of Section 7 of the RTI Act, 2005, the fee shall be paid by way of Demand Draft/Indian Postal Order (IPO)/Bankers Cheque/Treasury Challan payable to the Accounts Officer of the Public Authority at the following rate(s) :-
- (a) For Information provided in diskette or floppy : ` 50 (Rupees fifty) per diskette or per floppy.
- (b) For information provided in printed form : price so fixed for such publication or ` 2 (rupees two) per page of photo copy or for extracts from the publication.

Provided that no such fee shall be charged from the persons who are Below Poverty Line (BPL) and whose applications are accompanied with valid copy of BPL certificate issued by the Competent Authority. Subsequent production of BPL certificate shall not be entertained after receipt of application.”

Note :- The fees received by the PIO/Accounts Officer in the form of demand draft/Bankers Cheque/IPO shall be redeemed and deposited into the **Head of Account “0070 Other Administrative Services”** through Treasury Challan on a regular basis.

3. In Rule 10 of the Principal Rules, after sub-rule (2) the following sub-rule shall be added-

“(3) the Public Information Officer (PIO)/Accounts Officer shall keep the records of fee received and deposited into Government exchequer by them and shall submit a quarterly reports of applications and fees thereof to the Registrar of the Arunachal Pradesh Information Commission and to the Department of Administrative Reforms invariably”.

OFFICE MEMORANDUM

The 17th June, 2010

Subject : Transfer on deputation/foreign service of Central Government Employees to ex-cadre posts under the Central Government/ State Governments/Public Sector Undertakings/Autonomous Bodies, Universities/ UT Administration, Local Bodies etc. and vice-versa - Regulation of pay, Deputation (Duty) Allowance, tenure of deputation/ foreign service and other terms and conditions - regarding.

No. 6/8/2009.ESTT. (Pay II).—The undersigned is directed to refer to this Department's O.M. No.2/29/91-Estt. (Pay II) dated 5th January, 1994 as amended/revised from time to time. A need has been felt to consolidate all these orders in one place and accordingly, it has been decided, in consultation with Department of Expenditure, to bring out a self contained O.M. in supersession of O.M dated 5th January, 1994 and subsequent amendments on the subject, incorporating the provisions of earlier orders with suitable modifications, wherever necessary.

2. Application :

2.1. These orders will apply to all Central Government employees, who are regularly appointed on deputation/foreign service in accordance with Recruitment Rules of the ex-cadre posts, under the same or some other Departments of Central Government or under the State Governments/ Union Territories Administration/ Local Bodies or under Central/ State PSUs/Autonomous Bodies etc. set up or controlled by Central / State Governments provided the foreign service under such PSUs / autonomous bodies has been permitted in relaxation of appointment on immediate absorption basis. These orders will also cover the cases of regular appointment on deputation/Foreign Service of employees of State Government/Local bodies etc. as well as PSUs/ Autonomous Bodies of Central/ State Governments as per recruitment rules in the Central Government.

2.2. However, the following cases shall not be covered under these orders for whom separate orders exist:-

- Members of the All India Services and those deputed to posts, whose terms are regulated under specific statutory rules or orders;
- Officers appointed on deputation to posts under the Central Staffing Scheme (CSS) for whom separate orders as issued from time to time will continue to apply;
- Deputation to posts operated outside India;
- Appointments of a specific category of employees to a specified class of posts, such as appointments made in the Personal Staff of Ministers etc., In respect of which Special orders are already in existence. However, the terms and Conditions set out in this O.M. will apply to those cases to the extent these are not Specifically Covered under Such special orders.
- Appointments of the nature of deemed deputation or transfers to ex-cadre posts made in exigencies of Service with the specific Condition that no deputation (Duty) allowance Will be admissible - e.g. (i) interim arrangements In the event of conversion of a Government office/ organisation or a Portion thereof Into a PSU/ autonomous body or Vice-versa; and (ii) appointments to the same post in another cadre.

3. Scope of Terms 'deputation/ Foreign Service' - Restrictions on treating an appointment as on deputation/ Foreign Service.

- 3.1. The terms deputation/foreign service will cover only those appointments that are made by transfer on a temporary basis provided the transfer is outside the normal field of deployment and is in public interest. The question whether the transfer is outside the normal field of deployment or not will be decided by the authority which controls the service or post from which the employee is transferred.
- 3.2. The following types of appointments will not be treated as deputation/foreign service for the purposes of these orders:
- Appointment of serving employees made either by promotion or by direct recruitment from amongst open market candidates whether on permanent or temporary basis.
 - Permanent appointment made by transfer.
 - Temporary appointment made on the basis of personal requests of employees.
 - Arrangements necessitated by staff imbalances arising on re-organisation of offices on the same or different stations, subject to the specific condition that no deputation (duty) allowance will be admissible in such cases.
- 3.3. A person in a higher grade pay/scale of pay shall not be appointed on deputation to a post in a lower grade pay/scale of pay if the deputation is from central government to central government and also in cases where the scale of pay and dearness allowance in the parent cadre post and ex-cadre post are similar.
- 3.4. However, no appointment on deputation/foreign service shall be made from/to central government/ an organisation where the pay scale and DA in the parent cadre post and ex-cadre post are dissimilar, if the basic pay in the parent cadre increased by one increment plus dearness allowance(s) including interim relief if any, admissible to a person in the parent cadre post exceeds the basic pay plus dearness allowance (s) including interim relief, if any, at the maximum of the pay scale of the ex-cadre post. In the revised pay structure, the maximum of the scale would mean the sum of the grade pay of the ex-cadre post and maximum of the pay band PB 4 i.e. ₹ 67,000. For example, if the ex-cadre post is in the grade pay of ₹ 4,200, then the maximum would be ₹ 71,200 i.e. ₹ 4,200 plus ₹ 67,000 (maximum of PB 4).

4. Exercise of option :

- 4.1. An employee appointed on deputation/ foreign service, may elect to draw either the pay in the scale of pay of deputation/ foreign service post or his/her basic pay in the parent cadre plus deputation (duty) allowance thereon plus personal pay, if any. However, in case of government employees on deputation/ foreign service to CPSEs, this option will not be allowed and their pay will be governed in terms of the orders issued by Department of Public Enterprises vide OM dated 26th November, 2008 and clarifications issued thereafter.
- 4.2. The borrowing authority shall obtain the option of the employee within one month from the date of joining the ex-cadre post unless the employee has himself furnished the option.
- 4.3. The option once exercised shall be final.
- 4.4. However, the employee may revise the option under the following circumstances which will be effective from the date of occurrence of the same:
- When he/she receives proforma promotion or is appointed to non-functional selection grade or up-gradation of scale in the parent cadre;
 - When he/she is reverted to a lower grade in the parent cadre;
 - When the scale of pay of the parent post on the basis of which his emoluments are regulated during deputation/ foreign service or of the ex-cadre post held by the employee on deputation/ foreign service is revised either prospectively or from a retrospective date.
 - Based on the revised/same option of the employee, in the event of proforma promotion/ appointment to non-functional selection grade/revision/up-gradation of scales of pay in the parent cadre, his/her pay will be re-fixed with reference to the revised entitlement of pay in the parent cadre. However, if the initial option was for the pay scale of the deputation post and no change in option already exercised is envisaged, the pay already drawn in deputation post will be protected if the pay re-fixed is less.

Note : Revision in the rates of DA, HRA or any other allowance either in the parent or borrowing organisation shall not be an occasion for revision of the earlier option.

- 4.5. If the pay of an employee in his cadre post undergoes downward revision, the pay in the ex-cadre post is also liable to be re-fixed on the basis of revised pay and in accordance with the revised option or existing option if the employee does not revise his option.

5. Pay fixation :

5.1. When an employee on deputation/Foreign Service elects to draw pay in the scale of pay attached to the ex-cadre post, his/her pay may be fixed as under:

(i) Deputation from Central Government to Central Government

If the scale of pay/Grade Pay of the ex-cadre post is higher, the pay may be fixed after adding one increment to the existing pay in the Pay Band of the parent cadre post. The grade pay corresponding to the ex-cadre post would thereafter be granted in addition to this pay in the Pay Band. However, in cases where the fixation of pay in the ex-cadre post involves change of Pay Band also. If the pay in the Pay Band after adding the increment is less than the minimum of the pay band corresponding to the grade pay of the ex-cadre post, the pay in the Pay Band will be fixed at the minimum of the Pay Band.

In case the Grade Pay/scale of employee's cadre post and the ex-cadre Post are identical, the employee would continue to draw his/her existing basic pay.

In case the Grade Pay of the ex-cadre post is upto ` 10,000, the Basic Pay, from time to time after Pay fixation should not exceed the maximum of the Pay Band PB-4 (` 67,000) plus the Grade Pay of the post held on deputation. In case the ex-cadre post is in the HAG or HAG+ pay scale, the Basic Pay, from time to time after pay fixation should not exceed ` 79,000 or ` 80,000 respectively.

(ii) In foreign service/Reverse Foreign Service

(a) when the pay scale of the post in the parent Cadre and that attached to ex-cadre post are based on the same index level and the DA pattern is also same, the pay may be fixed as under (i) above.

(b) If the appointment is made to a post whose pay structure and/ or DA pattern is dissimilar to that in the parent organisation, pay may be fixed by adding one increment to the pay in the parent cadre post in the scale of his regular parent post (and if he/she was drawing pay at the maximum of the scale, by the increment last drawn) and equating the pay so raised plus dearness allowance (and additional or ad-hoc dearness allowance, Interim relief etc., if any) with emoluments comprising of pay plus DA, ADA, Interim relief etc., if any, admissible, in the borrowing organisation and the pay may be fixed at the stage in the pay scale of the ex-cadre post at which total emoluments admissible in the ex-cadre post as above equal the emoluments drawn in the cadre.

5.2. In cases of appointment from one ex-cadre post to another ex-cadre post where the employee opts to draw pay in the scale of the ex-cadre post, the pay in the second or subsequent ex-cadre post should be fixed under the normal rules with reference to the pay in the cadre post only, However, in respect of appointments to ex-cadre post carrying Grade Pay identical to that of the ex-cadre post(s) held on an earlier occasion(s), it may be ensured that the pay drawn in subsequent appointment should not be less than the pay drawn earlier.

5.3. In cases of appointments to a second or subsequent ex-cadre post(s) in a higher pay scale/Grade Pay than that of the previous ex-cadre post, the pay may be fixed with reference to the pay drawn in the cadre post and if the pay so fixed happens to be less than the pay drawn in the previous ex-cadre post, the difference may be allowed as personal pay to be absorbed in future increases in pay. This is subject to the condition that on both the occasions, the employee should have opted to draw pay in the scales of pay/Grade Pay attached to the ex-cadre posts.

Note - 1 : The term parent post and basic pay means the post held on regular basis in the parent organisation and pay drawn/ admissible in such a post respectively.

Note - 2 : An officer who may be holding a higher post on adhoc basis in the cadre at the time of proceeding on deputation/ Foreign Service would be considered to have vacated the post held on adhoc basis and proceeded on deputation/ Foreign Service from his/her regular post. During the period of deputation/ Foreign Service, he/she shall earn notional increments in the parent cadre post. On reversion, if he/she is re-appointed to the higher post on regular or adhoc basis his pay will get fixed with reference to the pay admissible in the lower post on the date of such re-appointment. In such cases, if his pay gets fixed at a stage lower than that of his junior(s) who continued to serve in the cadre, no stepping up will be admissible as per extant rules in so far as Central Government employees are concerned. However, if the pay so fixed is less than the pay drawn earlier while holding the post on ad-hoc basis the pay earlier drawn will be protected. Therefore, those Central Government employees who are already holding a higher post on ad-hoc basis or expecting it shortly in the parent cadre may weigh all relevant considerations before opting for deputation/ Foreign Service. This note of caution will be applicable to employees of other organisations wishing to apply for posts on deputation in Central Government, if governed by similar rules in parent organisation.

Note - 3 : Pay of an officer appointed on deputation/Foreign Service on adhoc basis pending selection of a regular incumbent may also be regulated in accordance with provisions of Para 5.1 & 6.1 of this O.M.

Note - 4 : The provisions of this Para as well as Para 6 will not apply to appointments on Personal Staff of Ministers. Such appointments will be regulated by separate specific orders issued by the Government in that behalf.

6. Deputation (duty) Allowance :

6.1. The deputation (duty) allowance admissible shall be at the following rates:

- (a) In case of deputation within the same station, the allowance will be paid at the rate of 5% of basic pay subject to a maximum of ` 2,000 p.m.; and
- (b) In other cases, Deputation (Duty) Allowance will be payable at the rate of 10% of the employee's basic pay subject to a maximum of ` 4,000 p.m.
- (c) The deputation (duty) allowance as above shall further be restricted as under:-

Basic Pay, from time to time, plus Deputation (Duty) Allowance shall not exceed the maximum of the Pay Band PB-4 (` 67,000) plus the Grade Pay of the post held on deputation in case the Grade Pay of the post held on deputation is upto ` 10,000. In case the post held on deputation is in the HAG or HAG+ pay scales, the Basic Pay, from time to time, plus Deputation (Duty) Allowance, should not exceed ` 79,000 and ` 80,000 respectively .

Note : Basic Pay in the revised pay structure means the pay drawn in the prescribed Pay Band plus the applicable Grade Pay but does not include any other type of pay like special pay/allowance etc.

The rates of deputation (duty) allowance as above shall take effect from 1st September, 2008.

Note : 1. The term 'same station' for the purpose will be determined with reference to the station where the person was on duty before proceeding on deputation.

Note : 2. Where there is no change in the headquarters with reference to the last post held, the transfer should be treated as within the same station and when there is change in headquarters it would be treated as not in the same station. So far as places falling within the same urban agglomeration of the old headquarters are concerned, they would be treated as transfer within the same station.

6.2. Special rates of deputation (duty) allowance may be admissible under separate orders in any particular area on account of the condition of living there being particularly arduous or unattractive. Where special rate is more favourable than that given in Para 6.1 above, employees deputed to the area will be given the benefit of the special rate.

6.3.1. If an employee with the permission of the competent authority, proceeds on deputation/Foreign Service from one ex-cadre post to another ex-cadre post in the same or another organisation without reverting to his parent cadre, and if the second ex-cadre post is at the same station as the first one, the rate of deputation (duty) allowance would remain unchanged.

6.3.2. In cases where a person on deputation/Foreign Service is transferred by the borrowing authority from one station to another without any change in the post held by him, the rate of deputation (duty) allowance will be re-fixed as per 6.1 (b).

7. Admissibility of a allowances and benefits while on deputation/Foreign Service :

7.1. Any project allowance admissible in a Project area in the borrowing organisation may be drawn in addition to deputation (duty) allowance.

7.2. Any special allowance granted to an employee in the parent Department under FR 9(25) or a corresponding, rule of parent organisation should not be allowed in addition to deputation (duty) allowance . However, the borrowing department may allow in addition to deputation (duty) allowance, under special circumstances, any special allowance attached to the post held by the employee in his/her parent Department, by suitably restricting the deputation (duty) allowance. This will require the specific and prior approval of Department of Personnel and Training.

7.3. In case special allowance is attached to the scale of pay of the ex-cadre post and the employee has opted to draw pay in that scale, then, in addition to the pay in that scale, he will also be entitled to draw such special allowance. However, such special allowance will not be admissible if he has opted to draw pay in the parent cadre scale/Grade Pay plus deputation (duty) allowance.

7.4. Personal pay, if any, drawn by an employee in his parent department will continue to be admissible on deputation/Foreign Service if he/she opts to draw pay in the parent cadre scale/Grade Pay plus deputation (duty) allowance. No deputation (duty) allowance on this personal pay will however, be admissible.

7.5. **Increments:-** The employee will draw increment in the parent cadre grade or in the scale of pay / Grade Pay attached to the deputation post as the case may be, depending on whether he has opted for the parent cadre pay plus deputation (duty) allowance or the pay scale/Grade Pay of the deputation post. If he has opted for pay scale/ Grade Pay of the deputation post, notional increments shall also continue to accrue to him in the post held on regular basis in the parent cadre/ organisation for the purpose of regulation of pay on repatriation to the parent post at the end of the tenure.

7.6. Admissibility of allowances and benefits while on deputation/ Foreign Service.

- (a) Such allowances as are not admissible to regular employees of corresponding status in the borrowing organisation shall not be admissible to the officer on deputation/ Foreign Service, even if they were admissible in the parent organisation.
- (b) Following allowances will be regulated with mutual consent of the lending and borrowing organisation:
 - (i) HRA/Transport Allowance
 - (ii) Joining time and Joining Time Pay.
 - (iii) Travelling Allowances and Transfer T.A.
 - (iv) Children Education Allowance.
 - (v) LTC.
- (c) Following allowances/facilities will be regulated in accordance with the rules as explained against each:
 - (i) **Dearness Allowance** :- The employee shall be entitled to dearness allowance at the rates prevailing in the borrowing organisation or in the lending organisation depending on whether he has opted to draw pay in the pay scale/Grade Pay of the ex-cadre post or the parent grade plus deputation (duty) allowance.
 - (ii) **Medical Facilities** :- This will be regulated in accordance with the rules of the borrowing organisation.
 - (iii) **Leave** :- An officer on deputation/ Foreign Service shall be regulated by the Leave Rules of the parent organisation. If however an employee proceeds from vacation department to non-vacation department, or vice-versa, he shall be governed by Leave Rule of the borrowing organisation. At the time of reversion from the deputation post to the parent cadre, the borrowing organisation may allow him/her leave not exceeding two months. The employee should apply for further leave to his Cadre Controlling Authority.

7.7. Leave salary/Pension/NPS Contribution :

- (i) As at present, allocation of leave salary and pension contribution between different Ministries/ Departments of Central Government and between Central and State Government has been dispensed with. In such cases of deputation from Central Government to State Government and vice-versa, liability for bearing leave salary vests with the Department from which the officer proceeds on leave or which sanctioned leave and no contributions are payable to the lending organisation. Liability for pension/ employee's contribution to CPF will be borne by the parent department, to which the officer permanently belongs at the time of retirement and no proportionate contribution will be recovered.
- (ii) In case of deputation of Central Government employees on Foreign Service terms to Central Public Sector Undertakings/ State Public Sector Undertakings and Autonomous Bodies/ etc., leave salary contribution (except for the period of leave availed of on foreign service) and pension contribution/CPF (Employer's share) contribution are required to be paid either by the employee himself or by the borrowing organisation to the Central Government.
- (iii) In cases of reverse deputation from Central Public Sector Undertakings/ State Public Sector Undertakings/ Autonomous Bodies/local bodies to Central Government, the question regarding leave salary and pension contribution will be decided by mutual consent.
- (iv) In case of employees covered under New Pension Scheme (NPS), the borrowing department shall make matching contribution to the NPS account of the employee.

8. Tenure of deputation/Foreign Service :-

- 8.1. The period of deputation/Foreign Service shall be as per the Recruitment Rules of the ex-cadre post or 3 years in case no tenure regulations exist for the ex-cadre post.
- 8.2. In case where the period of deputation/Foreign Service prescribed in the recruitment rules of the ex-cadre post is 3 years or less, the Administrative Ministry/borrowing organisation may grant extension upto the 4th year after obtaining orders of their Secretary (in the Central Government)/ Chief Secretary (in the State Government)/ equivalent officer (in respect of other cases) and for the fifth year with the approval of the Minister of the borrowing Ministry/ Department and in respect of other organizations with the approval of the Minister of the borrowing Ministry/Department with which they are administratively concerned.

- 8.3.1. The borrowing Ministries/Department /Organisations may extend the period of deputation upto the fifth year where absolutely necessary in public interest, subject to the following conditions:
- (i) The extension would be subject to the prior approval of the lending organisation, the consent of the official concerned and wherever necessary, the approval of the UPSC/ State Public Service Commission and Appointment Committee of Cabinet (ACC).
 - (ii) If the borrowing organisation wishes to retain an officer beyond the prescribed tenure, it shall initiate action for seeking concurrence of lending organisation, individual concerned etc., six months before the date of expiry of tenure. In no case it should retain an official beyond the sanctioned term unless prior approval of the competent authority to grant further extension has been obtained.
 - (iii) No further extension beyond the fifth year shall be considered.
- 8.3.2. Where extension is granted upto the fifth year, the official concerned will continue to be allowed deputation (duty) allowance, if he/she has opted to draw deputation (duty) allowance.
- 8.4. There shall be a mandatory 'cooling off' period of three years after every period of deputation/Foreign Service upto Joint Secretary level posts and one year for Additional Secretary level posts.
- 8.5. A Central Government employee shall be eligible for deputation/Foreign Service to posts in State Government/ State Government Organisations/ Government of UTs/ Government of UTs Organisations/ Autonomous Bodies, Trusts, Societies, PSUs etc., not controlled by the Central Government only after he has completed 9 years of service and is clear from the Vigilance angle.
- 8.6. If during the period of deputation/ Foreign Service, on account of proforma promotion in the parent cadre the official concerned becomes entitled to a higher Pay Scale/ Pay Band & Grade Pay in the parent cadre vis-a-vis that of the ex-cadre post, the official shall complete his/her normal/extended tenure of deputation already sanctioned with the approval of the competent authority. The pay shall be regulated as under:
- (a) If the Grade Pay of the officer in the parent cadre becomes higher than that of the deputation post after getting proforma promotion, he may be allowed the pay in the Pay Band + Grade Pay of the post to which he is promoted till the time he completes the normal/extended period of deputation (if he gets proforma promotion in the extended period) already sanctioned, if he so opts. No extension in the period of deputation shall be allowed to him after completing the sanctioned period of deputation.
 - (b) If he draws the pay in the Pay Band + Grade Pay attached to the deputation post, on reversion to his parent cadre, his pay may be fixed by allowing him notional increments in his regular post in the parent department + the Grade Pay attached to it.
 - (c) If the Grade Pay of the officer in the parent cadre becomes higher than that of the deputation post on getting financial up-gradation under the ACP/MACP scheme, the officer may be allowed to draw the pay in the Pay Band + Grade Pay to which he becomes entitled to under the ACP/MACPS, if opted for by him, as laid down in Para 27 of Annexure-I to the DOPT OM No. 35034/3/2008 -Estt. (D) dated 19th May, 2009.

9. Premature reversion of deputationist to parent cadre :-

Normally, when an employee is appointed on deputation/ Foreign Service, his services are placed at the disposal of the parent Ministry/ Department at the end of the tenure. However, as and when a situation arises for premature reversion to the parent cadre of the deputationist, his services could be so returned after giving an advance notice of at least three months to the lending Ministry/ Department and the employee concerned.

10. Relaxation of conditions :-

Any relaxation of these terms and conditions will require the **prior concurrence** of the Department of Personnel & training.

11. Date of Effect :-

These orders will take effect from 1st January, 2006 and shall be applicable to all officers who were on deputation on 1st January, 2006 or appointed thereafter except for the revised rates of deputation (duty) allowance which shall be applicable from 1st September, 2008 as mentioned below Para 6.1 of this OM.

12. In so far as persons serving in the Indian Audit and Accounts Department are concerned, these orders will apply for deputation outside Indian Audit and Accounts Department as concurred in by the Comptroller and Auditor General of India.

Subject : Delegation of powers to Ministries / Departments/Borrowing Organisations to extend deputation tenure upto 7 years in cases of Deputations covered by DoP&T's OM No. 6/8/2009-Estt.(Pay-II) dated 17th June 2010 - regarding.

.....-ESTT.—This Department's **OM No. 6/8/2009-Estt.(Pay-II) dated 17th June, 2010** regulates Pay, Deputation (Duty) Allowance, Tenure of Deputation / Foreign Service and other terms and conditions on the subject of deputation / foreign service of Central Government employees to ex-cadre posts under the Central Government, State Governments, Public sector Undertakings, Autonomous Bodies, Universities Union Territories Administration, Local Bodies etc, and vice-versa (copy enclosed). Subject to **its applicability as provided in para 2 of the OM**, these instructions cover cases of deputation/ foreign service where Central Government is either lending authority or borrowing authority or both. It provides for duration of maximum Deputation Tenure as 5 years at a stretch. As per para 8.3.1 (iii) of this OM, no further extension beyond the fifth year shall be considered.

2. Various administrative Ministries/ Departments/ Borrowing Organisations have been approaching this Department for relaxation of the 5 year deputation tenure condition, on case to case basis, citing exigencies, quoting provisions of para 10 of the OM dated 17th June, 2010 ibid.
3. It has been decided that if the Administrative Ministries / Departments and other borrowing organizations wish to retain 'an officer beyond 5 years, they may extend tenure of deputation covered by OM No. 6/8/2009-Estt.(Pay-II) dated 17th June, 2010, where absolutely necessary in public interest, upto a period not exceeding 7 years at a stretch. This shall be done with the approval of the Minister of the borrowing Ministry / Department concerned and in respect of other organizations with the approval of the Minister of the borrowing Ministry/Department with which they are administratively concerned, keeping in view the exigencies and subject to fulfillment of all other requirements such as willingness and vigilance clearance of the Officer concerned, NOC of the lending authority, UPSC / ACC approval wherever applicable. Thus, no case of extension shall be referred to Department of Personnel & Training, New Delhi.
4. All other terms and conditions issued vide OM No. 6/8/2009-Estt.(Pay-II) dated 17th June, 2010 will remain unchanged.
5. In cases where the necessity to have deputation tenures longer than seven years is felt, the concerned Administrative Ministries / Departments / borrowing organisations may amend the relevant Recruitment Rules of such deputation post accordingly, after following the requisite procedure. No extension of deputation beyond 7 years is to be allowed unless provided in the relevant Recruitment Rules of such deputation post. It is reiterated that no case for extension beyond five years shall be referred to DoPT.
6. **It is also clarified that cases which are not covered by the OM dated 17th June, 2010 including those where Central Government is neither lending authority nor borrowing authority, will continue to be decided in terms of the relevant provisions/ rules/ instructions etc. governing them.**
7. These orders shall come into effect from the date of issue of this OM.

TERMS AND CONDITIONS

No. FOR 423/E(A)-2/88 Pt-II.—In exercise of the power conferred by the provision to Article 309 of the Constitution of India in supersession of all Recruitment Rules notified in the subject, except in respect of things done or omitted to be done before such supersession, the Government of Arunachal Pradesh is pleased to make the following rules to regulate the method of recruitment to the post (s) of “Scientist Group “A”, (Gazetted) in the Department of Environment and Forests (State Forest Research Institute) under Government of Arunachal Pradesh, namely :—

1. (i) **Short title and commencement** : (i) This rules may be called “The General Arunachal Pradesh, Scientist Group-‘A’ Gazetted (Non-Ministerial) Scientific and technical Recruitment Rules, 2017”.

(ii) They shall come into force on the date of their publication in the Arunachal Pradesh Gazette.

2. **These rules shall apply to the posts as specified in column 1 of the schedule Annexed to the Rules.**

3. **Number of Posts, Classification and Pay Band/ Grade Pay/Pay Scale :-** The number of posts, their classification and the Pay Band and Grade Pay/Pay scale attached thereto shall be as specified in column 2 to 4 in the schedule aforesaid.

4. **Method of Recruitment, Age limit and Other qualifications :-**The method of recruitment to the posts, age limit, qualification and other matters relating thereto shall be specified in column 5 to 13 in the schedule aforesaid.

5. **Disqualification :-** No person

(a) Who has entered into or contracted a marriage with a person having a spouse living or

(b) Who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for the appointment to the said post. Provided that such marriage is permissible under the personal law applicable to such person and the other party to marriage and there are other ground for doing so and which exempts any person from the operation of the rule.

6. **Power to relax :-** Where the Government of Arunachal Pradesh is of opinion that it is necessary or expedient so to do, he may by order for reasons to be recorded in writing and in consultation with selection board relax any provisions of these rules with respect to any class or category or person.

7. **Repeal and saving :-** All rules and procedures corresponding to these rules and procedures in force immediately before the commencement of these rules are hereby repealed, provided that any order made or action taken under the rules so repealed shall be deemed to have been validly made or taken under the corresponding provisions of these rules.

Nothing in these rules shall affect reservation/relaxation of age limit and other concession required to be provided for Scheduled Castes and Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Government of Arunachal Pradesh from time to time in this regard.

Flexible Complementing scheme

1. The Flexible Complementing Scheme (FCS) is an in-situ promotion scheme for scientist for which, criteria shall be proven merit and records of research. The assessment norms for promotion under FCS shall be regorous. Due emphasis shall be laid on evaluation of professional contribution and technical knowledge to ensure that only Scientist having to their credit demonstrable achievements or higher level of technical merit are recommended. Scientists recommended shall not only posses the requisite qualification, but, should also be engaged in Scientific and innovative activities as distinct from the mere applicable technical knowledge and further, the function discharged by them are relatable or identifiable to their academic specialization.

2. Scientists or Technical experts doing management or administrative work in the Ministries shall not be considered for upgradation under FCS. However, they shall be given benefit of upgradation under the Modified Assured Career Progression Scheme.

3. The scientists appointed on deputation or contract shall bot be eligible for flexible complementing scheme promotions (FCS). Only regular scientists of the Department of Environment and Forests shall be eligible for FCS promotion.

4. There shall be no retrospective promotion under FCS. The promotions under FCS shall be effective from date these are approved by the appointing authority.

5. The promotion under FCS shall be limited to posts carrying a Grade Pay of ` 8,900/- or lower.

6. The promotion under FCS shall be applicable only to those scientists and Technologist who hold scientific posts and are engaged in scientific activities and service as defined in GOI, MoPPG & P (DoPT) OM. No. AB-14017/37/2008-Estt.(RR) dated 10th September, 2010. For promotion under FCS, the scientist shall posses the following essential qualification namely : Masters degree in natural science or equivalent.

7. All the posts covered under FCS shall carry the following uniform pay band and grade pay, designation and the minimum residency period linked to performance as follows :-

8.1 The following of period of service shall count towards the minimum residency period necessarily required to be put up in the lower grade for promotion to the next higher grade, namely :

- (i) The period spent on deputation or Foreign service to another scientific post ;
- (ii) The period of study leave or any other leave for improving the academic accomplishment ;
- (iii) The period of maternity leave and leave taken in continuation of the same for a maximum period of one year.
- (iv) The period of earned leave not exceeding 180 days at a time sanctioned as per leave rules.

8.2 The period spent on deputation or Foreign Service to a non-scientific post and the period of leave on medical grounds, leave such as extraordinary leave availed on personal grounds shall not count towards the minimum residency period.

9. The regular services rendered excluding ad-hoc service/non-qualifying service, in a post shall count for the purpose of review for promotion to the next higher grade under FCS.

10. The exceptionally meritorious candidates with all outstanding grading shall be granted relaxation in the residency period, the relaxation being not more than one year on any single occasion, limited to maximum of two occasions in their entire career.

11. Field experience in research and development and experience in implementation of such scientific projects is compulsory for promotion of scientists recruited to the post in the Secretariat of the scientific ministries or Departments of higher grades under FCS.

12. Field experience of at least two years and five years respectively shall be essential for promotion to Scientists 'F'.

13. The criteria for field experience for different scientific activities have been elaborated under scientific activities and service rule under notification of GoI, DoPT No. AB-1407/37/2008-Estt. (RR) dated 10/09/2010. To meet this requirement, existing scientists at Headquarters shall be considered for appointment on deputation basis to the scientific laboratories or institutes or universities or other relevant scientific activities.

14. The period spent on acquiring essential qualifications prescribed for direct recruits shall not count towards experience. However, period spent on acquiring doctorate degree from recognized university or institute in cases where doctorate degree is not an essential qualification, subject to a maximum of two years, and period spent on the post doctorate research, in a university or research institute, as evidenced by certification by such university or institute and publication of research work in journals of repute, subject to maximum of two years, shall be counted as experience.

15. The eligible Scientist shall be given three chances for assessment for FCS for the next grade. In case a scientist does not qualify under FCS for three successive years of chances for up gradation to the next higher grade, he shall be covered under the Modified Assured Career Progression Scheme according to the provisions of the same.

16. Broad assessment process :

(a) The process for assessment for FCS promotions shall be undertaken twice a year, as on 1st Government/State Government in accordance with the FCS guidelines issued by the DoPT, Government of India from time to time.

(b) The process for assessment for FCS promotions shall be undertaken twice a year, as on 1st January and 1st of July every year. The process shall be initiated at least 3 months in advance.

(c) Cases of those scientists who have completed or will complete the minimum residency period as on the cut-off dates of assessment viz-1st January and 1st July, as the case may be, and have earned or will earn number of annual ACRs/APARs equal to or more the number of years minimum residency period for the period of preceding the cut-off dates of assessment, shall be considered for FCS assessment.

17. There shall be two levels of assessment for FCS. The assessment procedure shall be as prescribed below based on the APAR and the annual work report to be submitted by each scientist as prescribed in Annexure-IV of GoI, DoPT Notification No. AB-1407/37/2008-Estt. (RR) dated 10th September, 2010.

17.1 Level 1 Screening (Internal) :

(a) An Internal Screening Committee shall be constituted by the State Government for evaluation of annual work reports vis-a-vis criteria for up-gradation under FCS. Level 1 Screening Committee shall assess the Scientists based on Annual Confidential Report or Annual Performance Appraisal Report and give its report and recommendations with specific reason, on Screening in or 'Screening out' of the eligible candidates.

(b) Candidates who are 'Screening out' in level screening process shall be considered again after one year when they earn at least one more Annual Confidential Report or Annual Performance Appraisal Report and shall be subjected to the prescribed screening process again.

(c) All scientists eligible according to the provisions of FCS and who meet the bench mark of 'Good' for upgradation to Scientist 'C' and 'Very Good' for upgradation to Scientific 'D' and above would be screened in. The internal screening committee would report on the scientific content or work done by the Scientist in the prescribed format and same would be made available to the external assessment committee.

17.2 Level 2 Screening (External) :

(a) Scientists 'Screening in' by the level 1 screening committee shall be placed before level 2 screening committee.

(b) Such 'Screening in' candidates shall be called for interview by level 2 Screening Committee.

(c) Level 2 Screening Committee shall be free to devise its process and procedure for assessment, which may include presentation by the candidates, interview etc.

(d) Level 2 Screening Committee shall in each case, document specifically through a one page summary, the specific content of work done justifying the merit and the suitability of the candidates for promotion to the next higher grade.

(e) The level 2 Screening Committee shall specially certify that the Scientists recommended meet all the criteria for in-situ promotion under FCS as prescribed under the rules.

(f) The level 2 Screening Committee shall make its recommendations on the basis of assessment of Annual Work Reports, presentations made by the candidates before it, performance during the interview, academic and professional record of the candidates, research and development experience of the candidates evidenced by publication of research work in journals of repute, and such other factors or parameters as the committee may consider necessary.

(g) Candidates who fail to obtain the minimum required marks in the level 2 screening as prescribed by the State Government shall go through the entire screening process viz level 1 Screening and level 2 Screening again after one year, when they earn at least one more Annual confidential Report or Annual Performance Appraisal Report.
