## ORDER.

It is directed that the Pre-Board Examination of Classes X and XII will be conducted in the month of January every year as per the Cabinet decision vide NO.CAB/M-10/2018/724, Dated 20th August'2018 only those who secure minimum 33% and above marks in the Pre-Board will only allowed to appear in the CBSE and minimum 80% attendance is mandatory for appearing in any final examination, otherwise the students will debarred from final examination.

The conduct of Pre-Board examination shall achieve the following objectives:-

- 1. It will screen the students for AISSE /AISSCE through conduct of Pre-Board examination and will make the students serious and regular in their studies.
- 2. Conduct of Pre-Board examinations in the CBSE pattern will provide necessary practice of facing examinations and enhance confidence of the students before they actually appear in the CBSE
- 3. It will significantly increase pass percentage of the students in the AISSE (Class X) and AISSCE (Class XII) CBSE examinations.
- 4. It will make the subject teachers accountable for the completion of the courses well in time.
- 5. The result of Pre-Board examinations in different subjects will provide the opportunity to improve further and teachers to take remedial classes before the CBSE Board examination.
