NOTIFICATION UNDER SECTION 25 OF RIGHT TO FAIR COMPENSATION AND TRANSPARENCY IN
LAND ACQUISITION, REHABILITATION AND RESETTLEMENT ACT, 2013

The 23rd December, 2016

No. LM-149/2011.— 1. Whereas, the declaration under Section -6 of Land Acquisition Act, 1894 dated 13th December, 2012 was published in the Gazette of Arunachal Pradesh on 18th December, 2012 as also in newspapers, the last such publication being on 29th December, 2012 for acquisition of land required for the development/execution of Simang-II (66 MW) Hydro Electric Projects under ADC administrative HQ Boleng, Siang District ; and

2. Whereas, As per Section-11-A of Land Acquisition Act, 1894 "The Collector shall make an award under Section 11 within a period of two years from the date of the publication of the declaration i.e. latest by 29th December, 2014 ; and

3. Whereas, Government of Arunachal Pradesh, by exercising its power vested under Section 25 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 read with Section 24(1) (a) of the said act, extended the above period stipulated under Section-11 A of the Land Acquisition Act, 1894 for making award in respect of Simang -II (66 MW) HEP, by another 12 (twelve) months i.e. upto 29th December, 2016 ; and

4. Whereas, the award under Section 11 of Land Acquisition Act 1894 (corresponding Section 23 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013) could not be finalized or made so far and is not likely to be finalized by the last date i.e. by 29th December, 2016 ; and

5. Whereas, the Deputy Commissioner of Siang District (under whose jurisdiction the said required land falls) has requested vide his letter No. SD/DEV-02/2015-16 (VOL-III)/256 dated 7th December, 2016 to extend the period for award of land under Section 11 of Land Acquisition Act, 1894 and under Section 25 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 ; and

6. Now therefore, in exercise of the powers vested under Section 25 of the Right to Fair Compensation and Transparency in Land acquisition, Rehabilitation and Resettlement Act, 2013 read with Section 24(1) (a) of the said act, the Government of Arunachal Pradesh hereby extends the period stipulated under Section 11A of the Land Acquisition Act, 1894 for making award in respect of Simang-II (66MW) HEP, Boleng Circle, Siang District, under Section -25 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, by another twelve (12) months i.e. by 29th December, 2017.
