## PRELIMINARY NOTIFICATION

(Issued under Section 11(1) of Land Acquisition, Rehabilitation and Resettlement Act, 2013)

The 30th March, 2017

No.LM-165/2011(Pt).—WHEREAS, the powers and functions of the appropriate authority under the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 vest with the Governor of Arunachal Pradesh which shall be exercised and discharged by him within the state ;

WHEREAS, it appears to the Governor of Arunachal Pradesh that land is likely to be needed at the locality or localities more fully described in the Schedule below for a public purpose, namely construction of a "2 Lane National Highway" under Trans Arunachal Highway (NH 229) Project at Segment-1E from Sede to Pakro, via-Patiwa, Veo and Taroyar at Chainage 0.00 to 15+800 as per the new alignment in the strop plan submitted by the PWD, Highway, Arunachal Pradesh, falling under the jurisdiction of the Deputy Commissioner, East Kameng District.

AND NOW, THEREFORE, this notification is made under the provision of Section-11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and to all whomsoever it may concern.

The Governor of Arunachal Pradesh hereby also authorizes the officers and officials for the time being engaged for the said purpose with their servants and workmen to enter upon and survey any land and do all other acts in pursuance of the provisions of Sub-section (2) of the above section.

Any person interested in the said land and whosoever has any objection to the acquisition of the said land, may within 60 (sixty) days from the date of publication of this notifications, file such objections in writing before the Deputy Commissioner, East Kameng District, Seppa, Arunachal Pradesh. The plan of the land may be inspected at his office.
