## NOTIFICATION

The 15th May, 2017

(Under Sec (10) of Balipara /Tirap/Sadiya, Frontier Tract Jhum Land Regulation, 1947)

No. LM-37/201(Pt)/2215.—**WHEREAS**, the power to acquire land is vested with the Governor of Arunachal Pradesh and it is the competence of the government to notify any land within the state of Arunachal Pradesh for public purpose under sec (10) of Jhum Land Regulation, 1947.

**AND WHEREAS**, the Governor of Arunachal Pradesh is satisfied that the land mentioned in the schedule below is needed for public purpose namely for establishment of **BoP SSB** falling under Kalaktang in West Kameng District, Bomdila.

**AND WHEREAS**, compensation will be paid as per provision of the Jhum Land Regulation, 1947.

**AND NOW THEREFORE**, the Governor of Arunachal Pradesh, do hereby declare that the land described in the schedule below more or less is hereby notified for the above mentioned purpose under sec (10) of Balipara/Tirap/Sadiya Frontier Tract Jhum Land Regulation, 1947.

**AND THEREFORE**, the Deputy Commissioner, West Kameng District, Bomdila is hereby directed to take possession of the above notified land subject to NOC, from the department of **ENVIRONMENT & FORESTS**.

Any person who has any objection to the acquisition of said land for the said purpose may file such objection in writing to the office of the Deputy Commissioner, West Kameng District, Bomdila, within **30 (thirty)** days from the publication of this notification by clearly stating the reason for such objection and the Deputy Commissioner, in his capacity shall dispose of the same after giving reasonable opportunity of hearing to extinguish the claim of the land owners.
