NOTIFICATION

No.PERS-39/2014.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Arunachal Pradesh is pleased to make the following rules further to amend the Recruitment Rules to the post of Junior Analyst in the Department of Administrative Reforms, Arunachal Pradesh Civil Secretariat, Government of Arunachal Pradesh namely:-

1. **Short title and Commencement** :- (i) These rules may be called the **General Arunachal Service Recruitment Rules to the post of Junior Analyst (2nd Amendment) Rules, 2017**.
2. **Amendment** :- In Principal Rule notified vide No. OM-49/88 dated 5th February, 2001 and Recruitment Rules (First Amendment) notified vide No. OM-49/88 dated 23rd December, 2004 for the existing entries, the following entries shall be substituted, namely:-
 - (i) In column 2, "5(five) posts subject to variation dependent on workload."
 - (ii) In column 4, "PB-3, ₹ 15600-39100 + GP 5400."
 - (iii) In column 12, "By promotion from the post of Assistant Section Officer (re-designated from Assistant) of Arunachal Pradesh Civil Secretariat having 8 (eight) years of regular service in the UDC) of Arunachal Pradesh Civil Secretariat with minimum 14 years of regular service in the grade of SSA with the following essential qualifications.
 - (a) Bachelor Degree from a recognized University.
 - (b) Qualified in the Basic Management Service (BMS) Course from ISTM, New Delhi, Government of India."
 - (iv) In column 13,

(a) Chief Secretary	— Chairman
(b) Commissioner / Secretary (Personnel/AR)	— Member
(c) A Secretary not connected with the works of the Department	— Member
(d) An APST Officer in the rank of a Secretary if none of the above members belong to APST	— Member
