### NOTIFICATION

No. 100/ARUN/01/2017.— **WHEREAS**, the seat of Shri Kameng Dolo in the Legislative Assembly of the State of Arunachal Pradesh, elected from 12-Pakke Kessang (ST) Assembly Constituency in the State, has become vacant on 8th February, 2017 by reason of his cessation of membership ; and

2. **WHEREAS**, a bye-election is to be held for the purpose of filling the vacancy so caused ;

3. **NOW, THEREFORE**, in pursuance of Section 150, 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby -

(A) **Calls upon** the said 12-Pakke Kessang (ST) Assembly Constituency in the State of Arunachal Pradesh, to elect, before the 5th August, 2017 (Saturday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person, belonging to any of the Scheduled Tribes of the State, for the purpose of filling the said vacancy in the Legislative Assembly of the State ;

(B) **appoints**, with respect to the said election, -

(a) the 12th July, 2017 (Wednesday), as the last date for making nominations ;

(b) the 13th July, 2017 (Thursday), as the date for the scrutiny of nominations ;

(c) the 15th July, 2017 (Saturday), as the last date for the withdrawal of candidatures ;

(d) the 29th July, 2017 (Saturday), as the date on which a poll shall, if necessary, be taken ; **and**

(e) the 5th August, 2017 (Saturday), as the date before which the election shall be completed ; and

(C) **fixes the hours from 07.00 a.m. to 04.00 p.m.** as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
