No. LR-31/84. — In exercise of power conferred under the Rule 143 of Arunachal Pradesh (Land Settlement & Records) Rules, 2012, the Governor of Arunachal Pradesh is pleased to authorized the Deputy Commissioner/Additional Deputy Commissioner/District Land Revenue & Settlement Officer (DLR&SO) to issue Land Holding Certificate to private land owners/farmers.

1. The Guidelines for issue of Land Permanent Certificate from time to time to private land owners must be followed.
2. The Certificate should be issued after checking the Register-Jamabandi or by field inspection and after preparing of the survey map of individual.
3. Land Holding Certificate must not be issued in Forest Land.
4. The Land Holding Certificate Format is attached as Annexure-“A”.
