## **NOTIFICATION**

The 29th August, 2017

No. SEDN/275/RR/BEO/2016.—In exercise of the powers conferred by proviso to Article 309 of the Constitution of India, the Governor of Arunachal Pradesh is pleased to make the following rules to regulate the method of recruitment to the post (s) of **Block Education Officer** in the Department of Education (Elementary) under the Government of Arunachal Pradesh, namely:-

- 1. Short title and commencement :-
  - (i) These rules may be called "The Block Education Officer (Group-B Gazetted), Recruitment Rules 2017".
  - (ii) They shall come into force on the date of publication in the Arunachal Pradesh Gazette.
  - (iii) These rules shall apply to the posts as Specified in column 1 of the schedule annexed to these Rules.
- 2. **Number of posts, classification and pay matrix : -** The number of posts, their classification, pay matrix attached thereto shall be as specified in Columns 2-4 to the Scheduled annexed.
- 3. **Method of recruitment, age limit and other qualification : -** The method of recruitment to the posts, age limit, qualifications and other matters relating thereto shall be as specified in columns 5-13 of the Schedule aforesaid.
- 4. **Disqualification:** No person:
  - (a) who has entered into or contracted a marriage with a person having a spouse living; or
  - (b) who having a spouse living, has entered into or contracted a marriage with any other person shall be eligible for appointment to the said post.

Provided that the Governor of Arunachal Pradesh may if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for doing so, exempt any person from the operation of these rules.

- 5. **Power to relax: -** Where the Governor of Arunachal Pradesh is of opinion that it is necessary or expedient so to do he may, by order for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. **Saving: -** Nothing in these rules shall be effect reservation/ relaxation of age limit and other concessions required to be provided for Arunachal Pradesh Scheduled Tribe and other special categories of the persons in accordance with the order issued by the State Government from time to time in this regard.
