NOTIFICATION

The 29th August, 2017

No. PERS-70/2017.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Arunachal Pradesh is pleased to make the following Rules further to amend the Arunachal Pradesh Civil Service Rules, 2006, namely :-

1. **Short title and commencement:** - (i) These Rules may be called the Arunachal Pradesh Civil Service (Amendment) Rules, 2017.

(ii) They shall come into force on the date of their publication in the Arunachal Pradesh Gazette.

2. **Amendment:** - In Principal Rule Notified vide No. PERS-53/97/3045 dated 18th July, 2007.

A. (i) In Part-III, in Rule 5, in Sub-Rule 2 in clause (ii) for existing entries in sub-clauses (b) and (c) the following shall be substituted, namely :-

(b) He/she should hold an appointment under Government of Arunachal Pradesh in Pay Matrix, Level-5 ₹ 29,200-92,300 pm or above as per 7th CPC.

(c) He/she should have rendered not less than 10 years of continuous service in the post carrying pay in the Pay Matrix, Level-5 ₹ 29,200-92,300 pm.

(ii) After sub-clause (d), the following clause shall be inserted :-

(e) He/she should have earned successively 3(three) very good reports in his ACRs/APARs during the period of eligibility.

(iii) In Part-III, in Rule 5, for the existing entries of sub-rule (3) following shall be substituted, namely :-

“On receipt of a requisition from the Appointing Authority, the Deputy Commissioner and Secretary to the Department shall make nomination of suitable and qualified persons for selection to the Entry Grade of the service under Lateral Entry Quota within the prescribed time limit. The nomination of Departmental Candidates will be screened by a Screening Committee constituted by the Government. After due scrutiny and verification of all requisite documents and papers of the candidates the Screening Committee shall submit a list of eligible candidates to the Government. The list of eligible candidates, duly approved by the Competent Authority shall be forwarded to the Arunachal Pradesh Public Service Commission (APPSC) for selecting suitable candidates as per the existing vacancies by holding the interview/viva voce.”

B. In Rule 13, for the existing entries, the following entries shall be substituted, :-

“Constitution of Selection Committee :-

Recruitment under sub-rule (8) of Rule 4 shall be made on the recommendations of a Selection Committee Constituted by Arunachal Pradesh Public Service Commission (APPSC). The Principal Secretary/ Commissioner/ Secretary of Department of Personnel & Administrative Reforms and the Principal Secretary/Commissioner/ Secretary of the Department of General Administration /District Administration to the Government of Arunachal Pradesh shall also be the Members of the said Selection Committee to be constituted by the APPSC.”

- C. (i) In Rule 14 for the existing entries of sub-rule (1), the following shall be substituted, namely :-
- “The APPSC shall consider from time to time the cases of officers eligible under clause (b) clause (i) of sub rule-(2) of Rule 5 who have served in the respective cadre or posts, as the case may be, for less than 10 years of continuous service in a post carrying Pay in the Pay Matrix from level-5 and recommend a list of officers for appointment to the Government of Arunachal Pradesh after taking into account the actual vacancies at the time of selection and those likely to occur during a year. The selection for inclusion in the list shall be based on merit and suitability of candidate in all respect for appointment to the Service shall be finalized on the basis of performance in the interview/viva voce conducted by the Selection Committee constituted by the APPSC as per Rule 13.”
- (ii) Sub-Rule (2) of Rule 14, shall be deleted.
- (iii) In Rule 14, for the existing entries of sub-rule (7), the following shall be substituted :-
- “The Select List so prepared by the Commission shall finally be approved by the Government after taking into account the changes if any. If any recommendations made by the Commission are not accepted, the reasons for non-acceptance shall be intimated to AAPSC while communicating the decision of the Appointing Authority, unless it has been decided to withhold the reasons for disagreement in public interest.”
- (iv) In Rule 14 : “ The Word “**COMMITTE**” wherever appear shall be substituted by the words “Arunachal Pradesh Public Service Commission” (APPSC).”
