NOTIFICATION

The 22nd September, 2017

No.DFCS/PDC-3(CONTRACT)2016 (Part).—In partial modification of the guidelines for appointment of District Public Distribution System (PDS) Landroute Carriage Contractor for procurement, drawal, lifting and transportation of Public Distribution System (PDS) Items from the Food Corporation of India, notified vide Notification No.DFCS/PDC.3(CONTRACT)2016 dated 16th January, 2017, the Government of Arunachal Pradesh is pleased to amend Sub-Clause (ii), (iii) and (v) of Clause-I in the said notification as under : -

1. For Sub-Clause (ii) of Clause I, the following shall be substituted :-

“(ii) Henceforth, the concerned Deputy Commissioners, Arunachal Pradesh will issue/publish Notice Inviting Tender (NIT) for appointment of District Public Distribution (PDS) Landroute Carriage Contractor by inviting : -

- (a) At first instant only from the interested Registered Cooperative Societies, registered under the Arunachal Pradesh Cooperative Societies Act, 1978 located its business activities in the concerned district of Arunachal Pradesh and on failed/ not qualified/ acceptable as per terms and conditions of the tender.
- (b) At second instant from interested Registered Society Non-Governmental Organizations (NGO's); registered under the Arunachal Pradesh Societies Act, 1978 located it social activities in the concerned district of Arunachal Pradesh having valid trading license and experienced in carriage of Foodgrains and allied activities in any Govt. Department, Central Govt. Agencies/ Undertakings and Food Corporation of India and on failed /not qualified/ acceptable as per terms and conditions of the tender.
- (c) At third instant from local firms/ interested individuals/ businessmen of the concerned district having valid trading license and experienced in carriage of Foodgrains and allied activities in any Govt. Department, Central Govt. Agencies/Undertakings and Food Corporation of India.

The sealed tenders in respect of clause 1(b) of registered Society Non-Governmental Organizations (NGO's) will be opened and taken for process by the Board of Officers, if there is no valid tender found from registered cooperative societies and otherwise tender in the respect should be treated stands terminated and the tender paper will be returned to its owner. Further, the sealed tender in respect of Clause 1 (c) of local firms/individuals/ businessmen will be opened and taken up for process only if there are, no valid tender found from Registered Society Non-Governmental Organizations (NGO's) and otherwise the tender in this respect should be treated stands terminated and the tender paper will return back to its owner”.

2. For Sub-Clause (iii) of Clause-I, the following shall be substituted : -

“(iii) In the event of non-participation by tenderers of that particular district, the concerned Deputy Commissioner shall take immediate simultaneous action to re-float open tender (Notice Inviting Tender) by inviting tenderers from the nearest adjoining/ neighbouring districts :-

- (a) At first instant only Registered Cooperative Societies under the Arunachal Pradesh Cooperative Societies Act, 1978 of the nearest adjacent/ neighbouring districts shall be allowed to participate in the tender process.
- (b) At second instant from interested Registered Society Non-Governmental Organizations (NGO's) of the nearest adjacent/ neighbouring districts registered under the Arunachal Pradesh Societies Act, 1978 located it social activities in the concerned district of Arunachal Pradesh having valid trading license and experienced in carriage of Foodgrains and allied activities in any Govt. Department, Central Govt. Agencies/Undertakings and Food Corporation of India and on failed / not qualified/ acceptable as per terms and conditions of the tender.

- (c) At third instant from interested firms/ individuals/ businessmen of the adjacent/ neighbouring districts having valid trading license and experienced in carriage of Foodgrains and allied activities in any Govt. Department, Central Govt. Agencies/Undertakings and Food Corporation of India and on failed /not qualified/ acceptable as per terms and conditions of the tender.

The sealed tenders in respect of clause 2(b) of registered Society Non-Governmental Organizations (NGO's) will be opened and taken for process by the Board of Officers, if there is no valid tender found from registered cooperative societies and otherwise tender in the respect should be treated stands terminated and the tender paper will be returned to its owner. Further, the sealed tender in respect of Clause 2 (c) of local firms/ individuals/ businessmen will be opened and taken up for process only if there are, no valid tender found from Registered Society Non-Governmental Organizations (NGO's) and otherwise the tender in this respect should be treated stands terminated and the tender paper will return back to its owner".

3. For Sub-Clause (v) of Clause I, the following shall be substituted : -

"(v) In case of expiry/termination/exhaustion of validity of the contract period and also in the event of any court order or any urgency/ circumstances beyond the control of the carriage contractor etc, the Deputy Commissioner shall make interim arrangement of a Carriage Contractor for a maximum period of 3 (three) months subject to obtain ex-post facto approval of the Government for regularization as per the terms and conditions mentioned below and shall take immediate simultaneous action to re-float open tender (Notice Inviting Tender) : -

- (a) At first from experienced and eligible registered cooperative societies of the concerned districts, registered under the Arunachal Pradesh Cooperative Societies Act, 1978 located its business activities in the concerned district of Arunachal Pradesh shall be appointed as interim District Public Distribution System Landroute Carriage Contractor.
- (b) At second instant, if there is no cooperative societies within the district, Registered Society Non-Governmental Organizations (NGO's) registered under the Arunachal Pradesh Societies Act, 1978 located its social activities in the concerned district of Arunachal Pradesh having valid trading license and experienced in carriage of Foodgrains and allied activities in any Govt. Department, Central Govt. Agencies/Undertakings and Food Corporation of India shall be appointed as interim District Public Distribution System Landroute Carriage Contractor.
- (c) At third instant, if there is no experienced Registered Society Non-Government Organizations (NGO's) within the district, local firms/ interested individuals/ businessmen of the concerned district having valid trading license and experienced in carriage of Foodgrains and allied activities in any Govt. Department, Central Govt. Agencies/ Undertakings and Food Corporation of India shall be appointed as interim District Public Distribution System Landroute Carriage Contractor".

4. For Clause VII, the following shall be substituted : -

"(VII) GODOWNS : - If any department godown is used by the carriage contractor, the monthly standard government approved rent shall be paid by the carriage contractor monthly to the concerned Deputy Commissioner who shall deposit it to the Govt. treasury under H/A-1456 Civil Supplies".

The other terms & conditions which are not specified herein shall remain unchanged.
