NOTIFICATION

(Issued Under Section (10) of Balipara/Tirap/Sadiya, Frontier Track (Jhum Land Regulation, 1947) against land to be acquired for construction of Power Grid Sub-Station at Koyu and Mebo area of East Siang District, Arunachal Pradesh)

No. LM-102/2016.—**WHEREAS**, the power and functions of appropriate authority under Jhum Land Regulation 1947 vested in the Governor of Arunachal Pradesh and which shall be exercised and discharged by him within the state.

AND WHEREAS, it appears to the Governor of Arunachal Pradesh that the land in the locality as described below are required to be taken by the Government for public purpose for construction of Power Grid Sub-Station at Koyu and Mebo area.

AND WHEREAS, under section 10 of Balipara/Tirap/Sadiya Frontier Track (Jhum Land Regulation, 1947) Government may acquire any Jhum land required for public purpose without formal acquisition proceedings by giving an opportunity to those having rights in the land and after payment of a reasonable compensation by the requiring department.

AND NOW, therefore, land in the locality as described below are hereby acquired under section 10 of Balipara/Tirap/Sadiya Frontier Track (Jhum Land Regulation, 1947) for public purpose namely for construction of Power Grid Sub-Station at Koyu and Mebo area. Any person who has any objection to the acquisition of the said land may file such objection in writing to the office of Deputy Commissioner, East Siang District, Pasighat within 30 (thirty) days from the date of publication of this Notification by clearly stating the reasons for objection.
