No. LM-214/2017.— Whereas it appears to the appropriate Government that a total of **200.056 acres** [80.962 Ha] of land is required in the **Bomja village Mukto Taluk** /Sub-division /Tehsil /Block [as applicable] **Tawang** district for public purpose, namely **for defence purpose [KLP]**.

A total of **Nil** (no.) families are likely to be displaced due to the land acquisition. The reason necessitating such is given below.

The Deputy Commissioner, Tawang District, Tawang is appointed as Administrator for the purpose of rehabilitation and resettlement of the affected families. This notification is made under the provisions of section 11[1] of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation Act, 2013 [30 of 2013], to all whom it may concern.

A plan of the land may be inspected in the office of the Collector and **DLRSO** on any working day during the working hours.

The Government is pleased to authorize **DC Tawang, DEO Tezpur**, Army and their staff to enter upon and survey land, take levels of any land, dig or bore into the sub-soil and do all other acts required for the proper execution of their work as provided and specified in section 12 of the said Act.

Under section 11[4] of the Act, no person shall make any transaction or cause any transaction of land i.e. sale /purchase, etc. or create any encumbrances on such land from the date of publication of such notification without prior approval of the Collector.

Objection to the acquisition, if any, may be filed by the person interested within 60 [sixty] days from the date of publication of this notification as provided under section 15 of the Act before Collector.

Since the land is urgently required for the project falling within the purview of section 40[2], it has been decided not to carry out the Social Impact Assessment Study.
