NOTIFICATION

The 22nd December, 2017

No. TRIHMS-38/2017.—WHEREAS, the Ministry of Health & FW, GoI vide No.U.12012/46/2012-ME(P-II) dated 19th February, 2014, has identified the General Hospital, Naharlagun as an integral establishment of Arunachal State Medical College.

AND WHEREAS, the State Government vide Notification No.DME, T&R/P&D/2/2015/Pt dated 12th July, 2016 has ordered that the Arunachal State Medical College into a Scientific society namely Tomo Riba Institute of Health and Medical Sciences, Arunachal Pradesh under the Societies Registration Act, 1860.

AND WHEREAS, the State Government vide Notification No.D-279/83 dated 25th June, 2017, has renamed the Tomo Riba State Hospital as Tomo Riba Institute of Health and Medical Sciences Hospital (TRIHMS Hospital) as the attached Teaching Hospital of TRIHMS Medical College.

AND WHEREAS, as per clause-2 (vii) and (viii) of the TRIHMS Bye-laws the Director TRIHMS shall function as Chief Executive Officer of the Institution and the attached Teaching Hospital shall remain under the administrative control of Director TRIHMS.

AND WHEREAS, as per clause-3 of the TRIHMS Bye-laws issued vide Gazette Notification No.DME, T&R/Estt-23/2016 dated 12th July, 2017 any institutions/sub-ordinate establishments under the Department of Health & Family Welfare shall be part of the Establishment of TRIHMS Society as may be required from time to time.

AND WHEREAS, as per clause-17 (i) of the TRIHMS Bye-laws the State Government vide order No.HFW-34/2017/472 dated 25th September, 2017 has appointed Director TRIHMS.

AND WHEREAS, all the staff presently working under the TRIHMS Teaching Hospital, Naharlagun who are regular State Government employees and posted as against sanctioned strength of the Hospital are liable to enjoy full benefits as regular Government employees as available to them as per extant norms of State Government.

NOW THEREFORE, in order to streamline the functioning of TRIHMS Teaching Hospital and Medical College, the Governor of Arunachal Pradesh is pleased to order the following :

1. In terms of Rule-14 of Delegation of Financial Power Rules, 1978 the Director TRIHMS shall function as Head of Office (HoO) in respect of TRIHMS Teaching Hospital, Naharlagun and exercise financial sanctioning power under Category-A as specified vide FDs OM No.Fin/E-II/13/Pt dated 22nd February, 2016.
2. The pay and allowances and other retirement benefits in respect of Director, TRIHMS and two supporting staff (i.e 1-Assistant and 1 Steno-III) who are regular Government servants of Health & FW Department and posted as against sanctioned post of TRIHMS Society vide order No.DME, T&R/Estt-28/2017 dated 9th May, 2017, may be drawn from the TRIHMS Hospital which shall continue to remain as a State Government Hospital.
3. Similarly, the pay and allowances and other retirement benefits (ORBs) in respect of regular State Government employees of TRIHMS Hospital may be drawn as per extant norms of the State Government through Treasury, under the administrative control of Director, TRIHMS which shall function as HoO for the TRIHMS Teaching Hospital. However, the Director TRIHMS shall be the controlling officer in respect of posts duly sanctioned by the Government from time to time in respect of TRIHMS Hospital.

4. The Commissioner (Health & FW) in his capacity as Head of the Department of TRIHMS Teaching Hospital and Chairman, EC of the TRIHMS Society, shall exercise financial power in respect of expenditures pertaining to Hospital Administration and TRIHMS Society up to the specified limits as per FD's OM No.FIN/E-13/86(Pt) dated 22nd February, 2016.
5. Proposal's of Hospital Administration requiring sanction in respect of expenditure beyond the delegated power of Commissioner (Health & FW), shall be accorded with the concurrence of FD.
6. Proposals of the TRIHMS Society, requiring sanction in respect of expenditures beyond the delegated powers of Chairman EC shall be accorded as per the bye-laws of the society, in which the Hon'ble Chief Minister, in his capacity as Chairman, Governing Council is empowered as per notification No.TRIHMS-33/2017 dated 26th July, 2017.
7. This order shall come into force with immediate effect.

This issues with the approval of Finance Department, Government of Arunachal Pradesh vide UO No. 294 dated 22nd December, 2017.
