NOTIFICATION

The 5th February, 2015

(Under Section (10) of Balipara/Tirap/Sadiya, Frontier Tract Jhum Land Regulation, 1947)

No. LM-229/2015/2597.—**WHEREAS**, the power to acquire land is vested in the Governor of Arunachal Pradesh and it is the competence of the Governor to notify any land within the state of Arunachal Pradesh for public purpose under Section (10) of Jhum Land Regulation Act, 1947.

AND WHEREAS, the Governor of Arunachal Pradesh is satisfied that the land mentioned in the schedule below is needed for public purpose namely for Construction of existing BRTF road to double lane NH standard alongwith improvement and re-alignment of 18,400 KM starting from 20 KM Taliha Via Bogne, Mara, Timba, Jeeba, Ganga Campunder Daporijo to Nacho BRTF double lane road.

AND WHEREAS, DLR & SO, Upper Subansiri District, Daporijo vide letter No. LM/DRJ-59/2011-12/688-1, dated 23rd November, 2015 inform that the acquisition of land will be needed for construction of existing BRTF road to double lane NH standard alongwith improvement and re-alignment of 18,400 KM starting from 20 KM Taliha Via Bogne, Mara, Timba, Jeeba, Ganga Campunder Daporijo to Nacho BRTF double lane road.

AND THEREFORE, the Deputy Commissioner, Upper Subansiri District, Daporijo is hereby directed to take possession of the above notified land subject to NOC, from the Department of **ENVIRONMENT AND FORESTS**.

Any person who has any objection to the acquisition of said land for the said purpose may file such objection in writing to the office of the Deputy Commissioner Upper Subansiri District, Daporijo within 45 (forty five) days from the publication of this Notification by clearly stating the reason for such objection and the Deputy Commissioner, Upper Subansiri District, Daporijo in his capacity shall dispose of the same after giving reasonable opportunity of hearing to extinguish and settle the claim of the land owners. The plan of the land may be inspected at the office of DLRSO, Aalo.
