## NOTIFICATION

The 21st December, 2017

**(Under Section 40 (1) of Right to Fair Compensation and Transparency in land acquisition, Rehabilitation and Resettlement Act -2013)**

No. LM-240/2017.—**WHEREAS**, the power and function of the appropriate authority under “The Right to Fair Compensation and Transparency in land acquisition, Rehabilitation and Resettlement Act 2013” is vest with the Governor, Arunachal Pradesh which shall be exercised and discharged by him within the state of Arunachal Pradesh.

**WHEREAS**, it appears to the Governor of Arunachal Pradesh that the land at the locality or localities more fully described in the schedule below is likely to be needed for construction of “ **Common Biomedical Waste Treatment Facility**” (CBWMF) at Hoj village under Toru Circle, at the expense of the said department.

**WHEREAS**, it appears to the Governor that the land is needed urgently for establishment of such plant that can dump wastage material from the vicinity of twin capital i.e., Naharlagun and Itanagar and adjoining area too.

**AND NOW THEREFORE**, this notification is issued under section 40 (1) of the “Right to Fair Compensation and Transparency in land acquisition, Rehabilitation and Resettlement Act-2013 for the acquisition of the land described in schedule below under urgency clause.

Any person who has any objection to the acquisition of said land for the said purpose may file such objection in writing to the office of Deputy Commissioner, Papum Pare District, Yupia, within 45 (forty five) days from the date of publication of this Notification by clearly stating the reason for such objection and Deputy Commissioner, Papum Pare in his capacity shall dispose off the same after giving reasonable opportunity and extinguish the claim.
