NOTIFICATION

The 1st March, 2018

No. AR-160/2015.—In exercise of the powers conferred by Article 318 of the Constitution of India, the Governor of Arunachal Pradesh is pleased to make the following Regulation further to amend Arunachal Pradesh Public Service Commission Regulations, 1988 namely :-

1. **Short title and commencement** :- (i) These Regulations may be called the Arunachal Pradesh Public Service Commission (Amendment) Regulations, 2018.
(ii) They shall be deemed to have come into force w.e.f. 11th August, 2017. i.e. the date of cabinet approval.
2. **Amendment to the Regulation** : (i) In existing clause 11 of Part IV of the Arunachal Pradesh Public Service Commission Regulations, 1988, following sub-clause (3) shall be substituted :-
- “3. **Pension under this Regulation shall be paid at the following rate, namely** :- The Non-Official Chairman and Non-Official Members of Arunachal Pradesh public Service Commission shall be paid pension in accordance with the rules applicable to the Non-Official Information Commissioner of Arunachal Pradesh Information Commission as prescribed under the State Information Commission Arunachal Pradesh (Pension) rules, 2014.”
(2) Under Part IV of the Regulations, after Clause 12, following new clause shall be inserted :-

"LEAVE SALARY"

- 12A. On the expiry of term in the Commission, the Chairman and the Members shall be entitled to receive cash equivalent of leave salary in respect of earned leave at their credit subject to a maximum 60 days Earned Leave @ 10 days per annum in the following manner :-

$$\text{Leave Encashment} = \frac{(\text{Pay} + \text{DA}) \times \text{number of days at credit,}}{30}$$
