NOTIFICATION

(Urgency clause under Section-11 of "The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

The 24th April, 2018

No. LM-288/2016.—Whereas, the power and functions of the appropriate authority under "The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013" vest in the Governor of Arunachal Pradesh which shall be exercised and discharged by him within the state of Arunachal Pradesh.

Whereas, it appears to the Governor of Arunachal Pradesh that the land is urgently needed at the locality or localities more fully described in the Schedule below for Border Out Post of ITBP at Aliney, Dembuen, Mipi and Maliney village under Dibang Valley District.

Whereas, it appears to the Governor that for national security of the country the land is urgently in need for establishment of Border Out Post.

And Now therefore, this notification is issued under Section 11 of "The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013" for the acquisition of the land described in the schedule below.

Any person who has any objection to the acquisition of the said for the said purpose may file such objection in writing to the office of the Deputy Commissioner, Dibang Valley District, Anini within 45 (forty five) days from the date of publication of this notification by clearly stating the reason for such objection and the Deputy Commissioner, Dibang Valley District, Anini in his capacity shall dispose off the same after giving reasonable opportunity to extinguish the claim.
