ORDER

The 19th May, 2018

No. AP/SYA - 140/2015.—In compliance of the Hon'ble High Court order dated 17th January, 2018, passed in WP (C) No. 279 (AP)/2015 and in WP(C) No. 190 (AP)/2016 and in continuation to Government's earlier Notification of even No. AP/SYA - 140/2015, dated 6th July, 2015, bifurcating the then Directorate of Sports and Youth Affairs into 2 (two) Directorate namely, - (1) The Directorates of Youth Affairs and (2) The Directorate of Sports, the Governor of Arunachal Pradesh is pleased to order as follows:

- That the name of the Officials/Officers who have opted for the Directorate of Sports are given in Annexure - I and the names of Officials/Officers who have opted for the Directorate of Youth Affairs are given in Annexure - II appended to this order which shall be final.
- 2. That the Directorate of Sports and the Directorate of Youth Affairs shall now be considered as independed and separate entity for all Official and Administrative purposes.
- That the name of Officers/Officials who have not opted any of the two Directorate are given in Annexure - III which shall remain as it is as provided in Government notification/order of even No. dated 6th July, 2015 and dated 10th July, 2015.
- 4. Shri D.K. Dinglow who is presently holding the post of Director of Youth Affairs on officiating basis has opted for Directorate of Sports where there is no sanctioned post of Director. Hence, Shri D. k. Dinglow, Director (Officiating) will remain as Director, Youth Affairs, Government of Arunachal Pradesh, on officiating basis.
- 5. Shri Gumnya Karbak is working in Youth Affairs and has opted for Directorate of Youth Affairs on 11th January, 2016 and thereafter revised his option for Directorate of Sports on 16th September, 2016. Therefore to settled the problem his first option has been considered otherwise opportunity of chance will have to be given at all and it will be difficult to decide the matter. Therefore, Shri Gumnya Karbak, Joint Director will remain as Joint Director (Officiating) under the Directorate of Youth Affairs Government of Arunachal Pradesh.
- 6. Shri S.P. Purkayastha Stenographer (Grade III) has opted for Youth Affairs Directorate. In fact, if Shri S.P Purkayastha, Stenographer is allowed to absorb in the Directorate of Youth Affairs then the Directorate of Sports will be left with no stenographer. Therefore, Shri S.P. Purkayastha, Stenographer will remain under Directorate of Sports Government of Arunachal Pradesh.
- That other terms and conditions which are not specified herein shall be governed by the aforesaid order dated 6th July, 2015 and relevant rules and orders issued by the Government from to time in this regard.
- 8. This issues as advised and vetted by Law Department vide U.O. No 238 dated 10th April, 2018 and U.O. No. 563 dated 18th May, 2018 and Administrative Reform Department Diary No. 4246 dated 4th May, 2018 and approval of competent authority.
