NOTIFICATION

The 7th May, 2018

(Issued under the provision of section-40(1) of Right of Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No. LM-173/2015(Pt).—**WHEREAS**, the power and functions of the appropriate authority under the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 vest in the Governor of Arunachal Pradesh which shall be exercised and discharged.

WHEREAS, it appear to the Governor of Arunachal Pradesh that the land likely to be needed at the locality or localities more fully described in the schedule below for Border Roads Namely" Acquisition of land for Border Roads at Chaglongam Circle of Anjaw District, Arunachal Pradesh for construction of Defence Road at the expense of the Government.

WHEREAS, it appears to the Governor that the land is needed in urgent for construction of Defence Road to meet up the requirement of the Indian Army at Anjaw District.

AND NOW THEREFORE, this notification is made under the provision of section-40 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 for acquisition of the land described in the schedule below under urgency clause.

Any person(s) who has any objections or claims to the acquisition of land for the said purpose may file such objection in writing to the Office of Deputy Commissioner, Anjaw District, Hawai within 45 (Forty five) days from the date of publication of the notification, clearly stating the reason for such objection and the Deputy Commissioner, Anjaw District, Hawai in his capacity shall dispose off the same after giving reasonable opportunity of hearing to extinguish the claim.
