PRELIMINARY NOTIFICATION

The 1st June, 2018

(Issued under Section-11 (1) of Land Acquisition, Rehabilitation and Resettlement Act, 2013)

No. LM-110/2016/990.—**WHEREAS**, the power and functions of the appropriate authority under "The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013" vest in the Governor, Arunachal Pradesh which shall be exercised and discharged by him within the state.

WHEREAS, it appears to the Governor of Arunachal Pradesh that the land is likely to be needed at the locality or localities more fully described in the Schedule below for a company, **namely Power Grid Corporation of India Limited (PGCIL) for construction 2x2.5 MVA 33/11 KV Power Sub-Station at Dumporijo (Lebe-Geko)** in Upper Subansiri District under comprehensive scheme for strengthening of Transmission and distribution system in Arunachal Pradesh for purpose, it is hereby notified that the land in the locality/ localities described in the Schedule below is likely to be acquired for the said purpose at the expense of the said company. The summary of social impact Assessment for the locality/localities described in the mentioned Schedule is also included below.

AND NOW THEREFORE, this notification is made under the provisions of section 11 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 and to all whomsoever it may concern.

The Governor of Arunachal Pradesh hereby also authorizes the officers/officials for the time being engaged for the said purpose with their servants and workmen to enter upon and survey any land and do all other acts in pursuance of the provisions of sub-section (2) of the above section.

Any person interested in the said land and whomsoever has any objection to the acquisition of the said land, may within 60 (sixty) days from the date of publication of this notification, file such objections in writing before the Deputy Commissioner, Upper Subansiri District, Daporijo, Arunachal Pradesh. The plan of the land may be inspected at his office.
