## MEMORANDUM

The 4th July, 2018

No. MUN/Estt-39/2018-2019.— **Whereas**, in pursuance of section 41 of Arunachal Pradesh Municipal Act, 2007 and sub-section (i) of section 2 of Arunachal Pradesh Municipal (Amendment) Act, 2010, the independent Chief Municipal Executive Officer, Municipal Executive Officer and Municipal Secretaries has been appointed for Itanagar and Pasighat Municipal Council.

**Whereas**, as per the provision contained under sub-section (2) of section 12 of the Arunachal Pradesh Municipal Act 2007, the Pasighat Municipal Council expired on 31st May, 2018 and Itanagar Municipal Council expire on 11th June, 2018 and stand dissolved on respective dates.

**And Whereas**, the Government of Arunachal Pradesh has appointed the Deputy Commissioner, Itanagar Capital Complex as Administrator for Itanagar Municipal Council and has appointed Deputy Commissioner, Pasighat, East Siang District as Administrator for Pasighat Municipal Council to perform and exercise all the powers and functions vested to the Municipal authorities under the Act or under any other law for the time being in force under provision of sub-section (2) of section 12 of the Arunachal Pradesh Municipal Act, 2007.

**And Whereas**, under provision of Rule 51 of the Arunachal Pradesh Municipal Business Rules, 2015 when a Municipality is dissolved, the administrator appointed by the State Government under section 472 of the Act shall be responsible for the administration of the affairs of the municipality and shall exercise the powers conferred upon the chief municipal Executive Officer/Municipal Executive Officer and the Municipal Secretary under rules 32,33,41,47 and 48.

**Now therefore**, in pursuance of sub-section (6) of section 12 of Arunachal Pradesh Municipal Act 2007, the appointment made under section 41 of Arunachal Pradesh Municipal Act, 2007 and sub-section (i) of section 2 of Arunachal Pradesh Municipal (Amendment) Act, 2010, i.e., Chief Municipal Executive Officer of Itanagar Municipal Council, Municipal Executive Officer of Pasighat Municipal Council and the Municipal Secretaries stands cancelled w.e.f. the date of appointment of Administrator, i.e., 31st May, 2018 for Pasighat Municipal Council and 11th June, 2018 for Itanagar Municipal Council. And consequently respective CMEO/MEO and Municipal Secretaries of IMC and PMC shall cease to hold the office to which they were appointed. They are directed to report to the concern Deputy Commissioners for further duties and orders.
