RE-NOTIFICATION

The 1st June, 2018

(Under Section (10) of Balipara/Tirap/Sadiya, Frontier Tract Jhum Land Regulation, 1947 this is in continuation with earlier notification vide No. LM - 37/2010 (Pt)/2215 dated 15th May, 2017)

No. LM-37/2010(Pt)/997.—**WHEREAS**, the power to acquire land is vested with the Governor of Arunachal Pradesh and it is in the competence of the Government to notify any land within the State of Arunachal Pradesh for public purpose under Section (10) of Jhum Land Regulation, 1947.

AND WHEREAS, the Governor of Arunachal Pradesh is satisfied that the land mentioned in the schedule below is needed for public purpose namely for establishment of BoP SSB falling under Kalaktang in West Kameng District, Bomdila.

AND WHEREAS, compensation will be paid as per provision of the Jhum Land Regulation, 1947.

AND NOW THEREFORE, the Governor of Arunachal Pradesh, do hereby declare that the land described in the schedule below more or less is hereby notified for the above mentioned purpose under Section (10) of Balipara/Tirap/Sadiya Frontier Tract Jhum Land Regulation, 1947.

AND THEREFORE, the Deputy Commissioner, West Kameng District, Bomdila is hereby directed to take possession of the above notified land subject to NOC, from the Department of ENVIRONMENT AND FOREST.

Any person who has any objection to the acquisition of said purpose may file such objection in writing to the Deputy Commissioner, West Kameng, Bomdila, within 30 (thirty) days from the publication of this notification by clearly stating the reason for such objection and the Deputy Commissioner, in his capacity shall dispose of the same after giving reasonable opportunity of hearing to extinguish the claim of the land owners.
