The Committee shall function and monitor the implementation of Pradhan Mantri Jan Vikas Karyakram (PMJVK) and PM's New 15-Point Programme for the welfare of minorities in the State as per the guidelines issued by Ministry of Minority Affairs.

The Committee shall hold quarterly meeting to review the progress of implementation of the plan and ensure that reports are sent to the Ministry of Minority Affairs, Government of India, New Delhi by 15th day of the next quarter by the Department of Social Justice and Empowerment and Tribal Affairs, Government of Arunachal Pradesh.

This notification supersedes earlier notification No. DSJE-30/2014 (MoMA) dated 5th August, 2014.
