NOTIFICATION

The 22nd August, 2018

No. HFW-08/2018.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, and in supersession of the Ward Sister Recruitment Rules, 1979, except as respect things done or omitted to be done before such supersession, the Governor of Arunachal Pradesh is pleased to make the following rules to regulate the method of Recruitment to the post (s) of Nursing Sister Group -B (Non-Gazetted), Non-Ministerial in the Department of Health and Family Welfare under the Government of Arunachal Pradesh, namely :-

1. **Short title and commencement** : (i) These rules may be called "Nursing Sister Group -B (Non-Gazetted), Non-Ministerial Recruitment Rules, 2018".

(ii) They shall come into force on the date of their publication in the Arunachal Pradesh Gazette.

2. They shall apply to the posts as specified in column 1 of the Schedule annexed to the Rules.

3. **Number of posts, classification and Pay Matrix** : The pay scale/Pay Matrix attached thereto shall be as specified in columns 2 to 4 in the Schedule aforesaid.

4. **Method of recruitment, age limit and other qualifications** : The method of recruitment to the posts, age limits, qualification and other matters relating thereto shall be specified in columns 5 to 13 of the Schedule aforesaid. Only those candidates who have registered under Arunachal Pradesh Nursing Council will be eligible for column No. 1 of Schedule.

5. **Disqualifications** : No person, —

(a) who has entered into or contracted a marriage with a person having a spouse living ; or

(b) who having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the said post. That the Government of Arunachal Pradesh may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other grounds for so doing, exempt any person from the operation of this rule.

6. **Power to relax** : Where the Governor of Arunachal Pradesh is opinion that it is necessary or expedient to do so, he may by order, for reasons to be recorded in writing and in consultation with the Selection Board/Arunachal Pradesh Public Service Commission/Department of Administrative Reforms relax any on the provisions of the rules with respect to any class or category of person.

7. **Repeal and Savings** : All Rules and Procedures corresponding to these Rules and procedures in force immediately before the commencement of these rules are hereby repealed, provided that any order made or action taken under the rules so repealed shall be deemed to have been validity made or taken under the corresponding provisions of the rules. Nothing in these rules shall affect reservation/relaxation of age limit and other concession required to be provided for the Arunachal Pradesh Scheduled Tribes and Special categories of persons in accordance with the order issued by the Government of Arunachal Pradesh from time to time in this regard.
