The Governor of Arunachal Pradesh is further please to order that in terms of sub-section (2) of Section 26 of “the Prohibition of Employment as Manual Scavengers and their Rehabilitation Act, 2013”, the state monitoring committee shall meet at least once in every six months and shall function as envisaged in section 27 and as per section 28, the State Monitoring Committee shall send such periodical report to the Central Government about progress of implementation of this Act, as the Central Government may require.
