## NOTIFICATION

The 18th January, 2019

[ISSUED UNDER SECTION 40 OF LARRACT, 2013]

No. LM-100/2012/(Pt.).— **WHEREAS**, the powers and functions of the Appropriate Government under the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Settlement Act, (hereinafter referred as LARR Act), 2013 vest in the Governor of Arunachal Pradesh, which shall be exercised and discharged by him within the state ;

**AND WHEREAS**, it appears to the Governor of Arunachal Pradesh that the land is needed at the locality or localities more fully described in the Schedule -I and Schedule-II below for construction of Green Field Airport at Hollongi, Papum Pare District, Arunachal Pradesh by Airport Authority of India for public purpose on an urgent basis ;

**AND WHEREAS**, a Notification U/S 11 (1) LARR Act, 2013 has already been issued vide LM-100/2012/777 and LM-100/2012/778 dated 11th January, 2019 ;

**AND WHEREAS**, the Greenfield Airport at Hollongi is a project of national importance having security interests and strategic requirement ;

**AND WHEREAS**, the Greenfield Airport at Hollongi will be located in the Itanagar Capital Complex in the strategically located State of Arunachal Pradesh ;

**AND WHEREAS**, the Governor of Arunachal Pradesh is satisfied that the land described below is urgently required to be acquired by invoking provisions of Section 40 of the LARR Act, 2013 ;

**AND WHEREAS**, the Governor of Arunachal Pradesh, in exercise of powers conferred Under Sub-Section (4) of Section 40 of the LARR Act , has decided that the provisions of Chapter-II to Chapter-IV of the LARR Act, 2013 shall not apply ;

**NOW THEREFORE**, the Governor of Arunachal Pradesh, in exercise of powers conferred under section 40 of LARR Act, 2013 directs the Deputy Commissioner, Yupia to take possession of land in accordance with provision of Section 40 of LARR Act, 2013.
