No. WCD-9/2012-13/Vol-I./14554-14703.—On accepting the recommendation of the State Level Selection Committee constituted for the purpose of selection of members for juvenile justice Boards (JJBs), Child Welfare Committees (CWCs), Inspection Committee-cum-District Advisory Boards etc. under Juvenile Justice Act, 2015, the Governor of Arunachal Pradesh is pleased to constitute/re-constitute Juvenile Justice Boards (JJBs) for the purpose of exercising the powers and to discharge the duties in relation to Children in Conflict with law, Child Welfare Committees (CWCs) for Children in need of Care and Protection and Constitution of Inspection Committee-cum-District Advisory Board, Monitoring and Evaluation Committee for the purpose of inspection of all Institutions registered under Section 4 (1), Section 27(1) and Section 54 (1) of the Juvenile Justice (Care and Protection of Children) Act, 2015 respectively in the following districts with immediate effect for a period of 3 (three) years.
