No. AR-72/2016.—It has been observed of late that some Secretaries to the Government of Arunachal Pradesh are very casual in handling matters of state and national importance by deputing their junior officers for meetings being held by Government of India. It is also observed that these junior officers are not fully aware of the facts that needs to be expressed during such meetings and end up misrepresenting the facts thus causing untold embarrassment to the State.

It must be understood that all meetings held by the Government of India especially those chaired by Joint Secretaries and above, Chairman of CPSUs and Central Government Agencies, should be taken with seriousness and only the Secretaries to the Government of Arunachal Pradesh and above should represent the State. The officers should also study the case in depth, analyse the facts and be fully prepared and brief the Chief Secretary before participating in the meetings. Further, where such meetings involve policy matters, this should be discussed in the Committee of Secretaries to gain collective knowledge of the issues at hand.
