No. AR-148/2016.—The Governor of Arunachal Pradesh is pleased to authorize the Arunachal Pradesh Public Service Commission (APPSC) to conduct recruitment of all Group-B (Non-Gazetted) posts under the Government of Arunachal Pradesh. Recruitment of Group-A and Group-B (Gazetted) shall continue to be recruited through the Arunachal Pradesh Public Service Commission. The present practice of conducting recruitment by the Appointing Authorities themselves shall be dispensed forthwith and henceforth the conduct of recruitment examinations for Group-B (Non-Gazetted) under the Government of Arunachal Pradesh shall be made through the Arunachal Pradesh Public Service Commission only in the first phase.

The Arunachal Pradesh Public Service Commission shall be responsible for fair and transparent conduct of recruitment and timely publication of the result. It shall maintain absolute integrity and care during the recruitment for proper advertisement, setting question papers, fair and procedural conduct of examination, safe custody of question papers and answer books, tabulation of marks obtained by candidates and publication of the results under the supervision of Chairman and Members of the Commission.

The Appointing Authorities shall inform actual vacancies and anticipated vacancies which are likely to arise during the course of the year, to the Commission in the 1st week of January every year in a requisition form prescribed for the purpose by the Commission and duly signed by the Appointing Authority. The Commission shall also prepare an examination calendar well in advance and conduct the recruitment examination for the vacant posts at each level received from all departments of the Government of Arunachal Pradesh, as per the schedule prescribed by the Commission. On receipt of requisition or intimation of vacancies from all the Departments of the Government of Arunachal Pradesh, the Commission shall issue advertisement(s) in the leading news papers inviting applications from the eligible candidates for appearing in the competitive recruitment examination. The application for the Competitive examination may be in such form as may be decided by the Commission.

A candidate, in order to be eligible for appearing in the competitive examination, must satisfy the following conditions, namely ; -

- (a) He/She shall be a citizen of India ;
- (b) He/She shall possess requisite educational qualification prescribed for the post/service in the Recruitment Rules for which the examination is being conducted ;
- (c) He/She shall not be less than the minimum age limit as prescribed under the Recruitment Rules on the date as specified in the advertisement of vacancies and not more than the upper age limit as prescribed in the Arunachal Civil Services and Civil posts (Upper age limit for direct Recruitment) Rules, 2014, and in the case of uniform services as prescribed by the Government of Arunachal Pradesh from time to time and ;
- (d) He/She shall fulfill all the conditions laid down in the Recruitment Rules prescribed for the said posts/ services for which the competitive examination is being held.

The decision of the Commission as to the eligibility or otherwise of a candidate for admission to any examination shall be final and binding. However, the Commission shall inform reason(s) for rejection of the application to the concerned candidate whose application has been rejected. Competitive Examination shall be held at a Centre or centers to be announced by the Commission after due assessment of the number of candidates appearing for the said examination.

The Commission may fix up such centers at the district or sub-divisional headquarters, if necessary, in consultation with the Deputy Commissioners of the District. The date, time and place of the examination shall be intimated to the candidates at least one month before the examination [and the same shall also be published sufficiently ahead of time in two leading national and two local dailies].

The recruitment of candidates shall be made through a written examination and personal interview conducted by the Arunachal Pradesh Public Service Commission. It shall conduct the written examination at the various examination centers, either online or offline. The Commission shall frame set of examination guidelines for conducting the examination for recruitment of officials at various levels in the most transparent manner.

The Arunachal Pradesh Public Service Commission shall obtain requisition from the Appointing Authorities in advance and conduct the examination in a time bound manner and furnish the final merit list of the candidates selected by the Commission to the Appointing Authority within 9 (nine) months from the date of receipt of requisition. It shall also put in place a mechanism for redressing the complaints and grievances registered by the candidates during the recruitment process in a time bound manner.

The Arunachal Pradesh Public Service Commission shall also hold departmental examination for the Fast Track Promotion of the eligible candidates at the entry level posts.

This notification shall come into force with immediate effect.
