No. DGM/Estt/MG-GP/2113/2013.—In exercise of powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Arunachal Pradesh is hereby pleased to make the following rules further to amend the Mineral Guard, Group-C Recruitment Rules, 2003 in the Department of Geology & Mining under the Government of Arunachal Pradesh.

1. **Short title and commencement** :- (i) These rules may be called the Mineral Guard (Geology & Mining), Group-'C' Recruitment (Amendment) Rule, 2017.  
(ii) They shall come into force on the date of their publication in the official Gazette.
2. **Amendment to the rules:-** In principle Rule notified vide order No. DGM (RR)-584/2003 dated 14th August, 2003 for the existing entries "Scale of Pay" wherever it appears, "Pay Band and Grade Pay/ pay scale" shall be substituted.

#### D. Terms and conditions:-

1. Check in time shall be allowed from 0500 hrs to 2100 hrs
2. Check out time shall be before 1200 hrs.

#### E. Parking of Vehicles

1. Parking of Vehicles within the premises of guest house being limited to six vehicles, it shall be provided on first come first basis.
2. Parking of rest vehicles of guest shall have to be arranged by the guest at his own at paid parking situated 300 Mt away from the guest house.
3. Drinking of alcohol in the guest house shall be strictly prohibited.
4. Prior to check in to rooms of the Guest house, occupants (except VIP's) shall have to furnish the Photo Id proof, which mandatory for submitting daily occupancy report by the Caretaker of the guest house to police station.
5. As per the deed of agreement with the owner of the apartment/flat, any type of sub-lease of the guest house for any purpose whatsoever, including the kitchen shall not be permitted.

The allotment of accommodation will be governed by the following rules & regulations.

1. Accommodation available in Arunachal Pradesh City Guest House is primarily intended for the Ministers, MLAs and Senior Officers of the Government of Arunachal Pradesh on duty.
2. If after allotting seats to the entitled categories of officials of the Government of Arunachal Pradesh accommodation if available, this may then be allotted to other officials- 1st preference being given to those of the Central Government and those on Government duty.

3. If due to exigency, seats are required to be provided to others, they shall be allowed to stay for a maximum period of 3 (three) days at a time which can be extended on written orders of the competent authority.
4. Even if room/seat are allowed to non-officials they shall vacate such accommodation on demand from the local authority, if Arunachal Pradesh Government officials are required to be provided with accommodation.
5. Normal reservation is available for a maximum period of 10 (ten) days.
6. If an occupant does not vacate the accommodation when permission lapses, he/she shall be charged with rates prescribed for others for such un-authorized occupation, besides penal action.
7. Application for reservation of accommodation shall be made to the Deputy Resident Commissioner, Guwahati at least 7 (seven) days in advance, specifying therein whether the applicant is on duty, or otherwise, dates and duration of stay, number of seats required, whether with or without family and such other connected information.
8. No reservation shall be made for marriage and such other private functions.
9. Those who intend to vacate the reservation so made, shall intimate to this effect in writing to the Deputy Resident Commissioner, Guwahati well in time. Rent for accommodation already reserved and not occupied beyond first 12 hours, shall be realized for the full reservation period.
10. Occupants shall be responsible for the proper use of furniture crockeries, fixture, fittings and such other items provided, loss/damage and breakage thereof shall be liable to compensation by the occupant(s) as determined by the reservation authority.
11. Catering service will be provided whenever possible as per rates and tariff by the local authority from time to time.
12. The occupants may place orders with Care-taker or In-charge of such for any type of food, snacks, breakfast, beverage etc. At least 6 (six) hours in advance.
13. The tariff, as notified by the local authority, shall be paid for such orders whether taken or not, unless cancelled well ahead.
14. Service charges of ₹ 2 (Rupees two) only shall be levied for such food and beverage items served inside the rooms.
15. No cooking shall be permitted in any place/room other than inside the kitchen.
16. Officers, on duty, using telephones shall be charged with prescribed rates which shall be paid immediately with necessary entry in the telephone Trunk Call Register.
17. Those who occupy the accommodation shall make necessary entries into the occupancy Register, under date and signature, immediately as required by the Care-Taker or In-charge of such accommodation.
18. Any complaint, which the occupant likes to record, shall be entered in the complaint Book maintained separately with the receptionist and not in the occupancy register.
19. The Government of Arunachal Pradesh reserves the right to amend, alter, relax, repeal one or more of these rules provided that the Government is of the opinion that special circumstances justify such action.
20. This order supersedes all earlier orders issued from time to time.
21. This order is issued with the approval of Government vide U.O No. 367 dated 13th November, 2017 & Secy (F&CS) U.O No. 01 dated 1st November, 2017.
