OFFICE MEMORANDUM

The 4th December, 2017

No. AR-107/2017.—In every Recruitment Rules/Service Rules, there is a mentioned that the Recruitment Rules/Service Rules so framed shall come into force from the date of publication in the Official Gazette. Further, as per Section 39 of the Arunachal Pradesh Interpretation and General Clauses Act, 1982, every Rule under any enactment shall be published in the Official Gazette, and they shall come into force on the day on which it is published in the Official Gazette. As such, any enacted Rules acquired the Status of a Rule only after the same is published in Official Gazette. Hence, clarification pertaining to Recruitment Rules is given as under :

- (i) Whenever a proposal for amendment of Recruitment Rules/Service Rules is submitted to Administrative Reforms Department, the proposal for such amendment should be accompanied by a copy of relevant Principal Rule duly published in the Arunachal Pradesh Gazette.

- (ii) Whenever a new Recruitment Rules/Service Rules is framed, such Rules must invariably be published in the Arunachal Pradesh Gazette before the Rules is put to application.
  - (iii) Whenever there is a subsequent changes in the number of post, pay scale, status of post, educational qualification, method of recruitment, composition of DPC etc. due to a Government decision, respective departments must take consequential action to amend the existing Recruitment Rules/ Service Rules immediately and thereafter, published the same in the Official Gazette after observing the due process of law.

Therefore, all the Heads of Department under the Government of Arunachal Pradesh is requested to follow the above invariably to abide by the provisions of Section 39 of the Arunachal Pradesh Interpretation of Rules and General Clauses Act, 1982.
