No. PWRS/E-2745/2015.—In the interest of public service, the Governor of Arunachal Pradesh is pleased to accord sanction for creation of following 26 (twenty six) numbers of temporary posts/units of various categories born under the establishment of Electrical Inspectorate under Department of Power (Elect) with immediate effect, whose respective Headquarters and area of jurisdictions will be as follows :

**(A) Description of posts :-**

(1) Chief Electrical Inspector [ in the rank of Chief Engineer (Power)	: 1 (one) No.
(2) Senior Electrical Inspector [ in the rank of Superintending Engineer (Elect)	: 2 (two) Nos.
(3) Electrical Inspector [(in the rank of Executive Engineer (Elect)]	: 9 (nine) Nos.
(4) Assistant Electrical Inspector [ in the rank of Assistant Engineer (Elect)]	: 14 (fourteen) Nos.
<b>TOTAL</b>	<b>26 (twenty six) Nos.</b>

**(B) Headquarters and area of jurisdictions of respective posts/units are as follows :**

- (a) CEI : Headquarter at Itanagar. CEI will be HoO for the Inspectorate in the State.
- (b) SEI (West) : Headquarter at Itanagar for Tawang, West and East Kameng, Papum Pare, Lower and Upper Subansiri, Siang, East/West/Lower and Upper Siang, Kurung Kumey, Kra-Daadi and Kamle District.

- (c) SEI (East) : Headquarter at Tezu for Lohit, Namsai, Anjaw, Dibang, Lower Dibang, Tirap, Longding and Changlang District.
- (d) EI : Headquarter at Bomdila for Tawang, West and East Kameng District.
- (e) EI : Headquarter at Itanagar for Papum Pare District.
- (f) EI : Headquarter at Ziro for Lower Subansiri, Kurung Kumey, Kra-Daadi and Kamle District.
- (g) EI : Headquarter at Pasighat for Siang, East Siang and Upper Siang District.
- (h) EI : Headquarter at Aalo/Basar (West Siang, Lower Siang and Upper Subansiri District.)
- (i) EI : Headquarter at Tezu for Lohit, Namsai and Anjaw District.
- (j) EI : Headquarter at Roing for Dibang and Lower Dibang Valley District.
- (k) EI : Headquarter at Deomali for Tirap and Longding District.
- (l) EI : Headquarter at Changlang for Changlang District.
- (m) Out of 14 (fourteen) posts/units of Assistant Electrical Inspectors so created, 2 (two) posts each will be placed under the disposal of EIs of Bomdila, Itanagar, Ziro, Aalo, Tezu and 1 (one) number each of that will be placed under the disposal of EIs of Pasighat, Roing, Deomali and Changlang respectively.

The expenditure is debitable to the Head of Account 2801 (Plan).
