OFFICE MEMORANDUM

Sub : **Implementation of the Scheme of Revision of pay of Teachers and equivalent cadres in Colleges on the recommendations of 7th CPC w.e.f 1st January, 2016.**

No.ED/HE-359/2009.—In pursuance of the decision conveyed by the Ministry of Human Resource Development, Department of Higher Education, GoI vide No. 1-7/2015-U.II(1) dated 2nd November, 2017 for revision of the scales of pay scales on the recommendation of the UGC in respect of teachers and equivalent cadres in the colleges and also in view of the of the Cabinet decision vide U.O No. CAB/M-16/2017/4056 dated 5th February, 2018, the Governor of Arunachal Pradesh is pleased to revise the pay scales of Principals/ Assistant Professors/Associate Professors/Librarians and equivalent academic cadres in the Government Colleges in the State of Arunachal Pradesh as shown in **Appendix- 'A'** enclosed herewith.

1. The revisions of the pay scales of teachers and equivalent academic staff shall be subject to various provisions of the scheme of revision of pay scales as contained in the letter of Ministry of Human Resource Development, Department of Higher Education, Gol vide No. 1-7/2015-U.II(1) dated 2nd November, 2017 and regulations issued by the UGC and amendment thereof from time to time in this behalf (copy enclosed).

2. The revision of pay under the scheme shall be effective from 1st January, 2016.

3. In addition to the revised pay, other allowances as applicable to the State Government employees issued by Government of Arunachal Pradesh from time to time shall be admissible to the teachers and equivalent academic staff in the Colleges.

4. The fixation of pay shall be done on the basis of the method contained in para-2 of the Ministry's letter dated 2nd November, 2017.

5. Payment of arrears on revised pay with effect from 1st January, 2016 shall be paid cash after making all statutory deductions as applicable and term of payment of arrear shall be as under :

(i) 50% arrears in current financial year, 2017-18.

(ii) Balance of arrears in the months of June, 2018.

6. Before disbursement of pay, an undertaking shall be obtained by the Head of Office from the Principals/ Assistant Professors/Associate Professors/Librarians to the effect that in the event any over payment made due to erroneous fixation of pay or otherwise, the excess amount shall be recovered from the pay.

7. Disbursement of the arrears is subject to availability of fund under "Salary" Head in the respective colleges.

8. Additional expenditure incurred due to payment of revised pay and arrears thereon shall be calculated and the claim should be submitted to the UGC for re-imbusement during the current financial year, 2017-18.

No. PERS-36/2014(Pt)/295.—WHEREAS, vide Government order No. PERS-36/2014 (Pt), dated 14th September, 2016, Dr. N. Lego (Osik) was placed under deemed suspension with effect from 15th June, 2016 on account of his conviction under prevention of Corruption Act and subsequent detention in North Lakhimpur Jail for more than 48 hours.

AND WHEREAS, the matter pertaining to his suspension was discussed and deliberated in the meeting of Suspension Review Committee headed by Chief Secretary.

AND WHEREAS, it was observed that Dr. N. Lego (Osik) has been convicted by the trial court on very serious charges and therefore revocation of his suspension order will have detrimental and demoralizing effect on all the fellow officers and will set a bad precedence in Government functioning.

AND WHEREAS, Government vide order No. PERS-36/2014 (Pt), dated 21st August, 2017, suspension of Dr. N. Lego (Osik) was extended for a further period of 180 days with effect from 9th September, 2017.

AND WHEREAS, after Considering the facts and circumstances of the case and after detailed deliberations, the SRC held on 1st March, 2018 recommended that the suspension of Dr. N. Lego (Osik), APCS be extended for a further period of 180 days with effect from 8th March, 2018.

AND WHEREAS, the Competent authority after due examination of all the facts circumstances of the case and documents placed on record has accepted the aforementioned recommendation of the Suspension Review Committee.

NOW THEREFORE, the Governor of Arunachal Pradesh, in exercise of powers conferred by the Rule 10 (6) of the CCS (Classification, Control and Appeal) Rules 1965, hereby extends the Suspension of said Dr. N. Lego (Osik), APCS (Admn. Grade), for a further period of 180 days with effect from 8th March, 2018.

It is further ordered that during the period that this order shall remain in force, the headquarters of Dr. N. Lego (Osik), APCS (Admn. Grade), should be "ITANAGAR" and shall not leave the headquarters without obtaining the prior permission of the undersigned.

No. PHE/Sectt.-32/96 Vol-I (one).—Consequent upon the recommendation of the Arunachal Pradesh Public Service Commission, vide No. PSC-R(B)/13/2017 dated 21st February, 2018 and his acceptance of the offer for the post of Assistant Engineer (Civil) in the Public Health Engineering and Water Supply Department vide No. PHE/Sectt 32/96 Vol-I (one) dated 28th February, 2018, the Government of Arunachal Pradesh is pleased to appoint Shri Kapu Takar, to the post of Assistant Engineer (Civil) in the Pay Band - 3 Scale of Pay ₹ 15,600 - 39,100 + 5400 (Grade Pay) of (Pre-Revised) per month plus other allowances as admissible under rules from time to time with effect from the date of his joining in the post. However, his seniority will be governed as per merit list of the Public Service Commission and as provided under rules.

Terms and Conditions :

1. The service of the appointees will be governed by the CCS (Temporary Service Rules) 1965 as amended upto date and liable to be terminated by the Government by serving one month's notice from either side.
2. The appointment will be governed by the relevant rules and orders of the Government of Arunachal Pradesh issued from time to time.
3. The appointment carries with the liability to serve in any of Arunachal Pradesh or outside where PHE & WS Department, Government of Arunachal Pradesh has an establishment, as decided by the Government from time to time in the interest of public service.
4. The appointees are likely to be required to undertake tours by air, road or foot in any part of Arunachal Pradesh or outside during the course of his service as Assistant Engineer in the Department.
5. The appointees will have to furnish details of your movable and immovable properties, within the four weeks from the date of issue of the order.
6. He will also have to furnish details of his family members.
7. The appointment will be subject to the production of release order from the previous employer (applicable in case of person who is in service) at the time of joining duty without which his joining will not be accepted.
8. The government servant shall not have more than one wife/husband at any time throughout his service. On default of his/her, the service of the Government servant may be terminated as per CCS (Conduct) Rule, 1964.
9. Confirmation in the post will be subject to receipt of good performance reports over a minimum period of 2 (two) years from the concerned Controlling Officer.
10. The appointees must report to his place of posting within 1 (one) month from the date of issue of this order failing which the appointment is likely to be treated as cancelled.
11. The other terms and conditions which are not specified herein shall be governed by the relevant rules and orders as may be in force from time to time.

During the period of attachment his pay and allowances shall be drawn from the establishments of Chief Engineer (W/Z) PHE & WS Department against over all vacancies of AEs/ASWs in the Department.
