No. STP/MUN-387/2018-19/424—Whereas, the various projects funding under scheme SMARTCITY, FFC, AMRUT, SWATCHA BHARAT MISSION, HOUSING FOR ALL, DAY-NULM, PMAY (U), works borne under State Plan /Non-Plan Sector, CSS, grants-in-aids, sanitation activities etc., are being implemented in the state of Arunachal Pradesh through Town Planning and Urban Local Bodies Department and in turn through Municipal Council mainly in Itanagar and Pasighat and in other notified town(s) through Deputy Director (UD & Housing) as Member Secretary of respective DUD As (District Urban Development Agencies).

AND WHEREAS, the post designated as Executive Engineer(s) under Municipal Council at Itanagar and Pasighat along with the subordinate Technical manpower are functioning as Executive Engineer in the Municipal Council as per order vide No. Mun/Estt-20/2013-14/dated Itanagar the 10th December, 2015.

AND WHEREAS, these two Executive Engineer(s) posted in the Council are executing the project(s) scheme(s) under aforesaid funding scheme. But practically the payment of bills/scrutinising of the bill are centrally scrutinised in the office of the Chief Municipal Executive Officer/ Municipal Executive Officer in both the Municipal Council. The centralised fund also are being crediting in the centralised Account under respective Chief Municipal Executing Officer/Municipal Executive Officer, while the power and function of the Executive Engineer(s) are not fulfilling in proper way when discharging their duties and implementing the project.

AND WHEREAS, the earlier notification issued vide No. DTP/MUN-20/2009-10/477-90 dated 8th July, 2015 at Rule 4(b), & (d) Rule-5, Rule-8(2) and Rule 19(1) and (2) empowers the Municipal Engineers for preparation of estimates, accord of Technical Sanction, supervision of works and exercise of power at par with the same power as officers of the corresponding rank(s) of Arunachal Pradesh Public Works Department.

AND WHEREAS, the ESC (Empowered Standing Committee) members in its meeting held on 12th April 2017 vide memo No. IMC/ESTT-13/2013-14/6070-75 have passed a resolution to empower Executive Engineer for DDO (Civil) and whereas the Arunachal Pradesh Municipal Account Manual vide chapter 6 page 176 and 195 also emphasises on decentralised DDO of various section/establishment within the municipalities, which also has the provision under Municipal Act, 2007 vide section 28(1) (2) (3-a, b, c) and 4 of the delegation of power and functions.

NOW, THEREFORE, the authority has decided that separate drawing and disbursing power to be given in the name/favour of the Executive Engineer (Civil) posted in the Itanagar Municipal Council, Itanagar and Pasighat Municipal Council, Pasighat. The respective Executive Engineer(s) shall function as account operating DDO (Drawing and Disbursing Officer) for implementation of the project(s) as mentioned and for that the centralised amount to be transferred to the Bank Account to be opened and operated by respective Executive Engineer(s) for implementation of such project(s). The Executive Engineer(s) of Itanagar and Pasighat are placed under category 'C' of the delegation of financial power.

And in partial modification of the rule-20 of the notification vide No. DTP/MUN-20/2009-10/477-90 dated 8th July, 2015, the authority hereby empowers the Executive Engineer(s) of the respective Municipal Council to exercise the rule-20 henceforth. Also in partial modification of the Notification vide No. MUN/Estt-18/2013-14/3296-709 dated Itanagar the 16th January, 2014, the power relating to works as per CPWD Manuals shall be exercised by the Executive Engineer(s) and Engineers of the Urban Local Bodies posted in the municipalities. The municipal Engineers in exercise of the CPWD manual shall exercise the same power as Officers of the corresponding ranks of the Arunachal Pradesh Public Works Department. Also, the office of Executive Engineer of Itanagar and Pasighat Municipal Council is declared as Head of Office.

Further, in order to avoid embezzlement/over payment etc. the Executive Engineer(s) concerned shall follow the laid down norms as of GFR (General Financial Rules) CPWD Manuals and Rule-9(1-a), 2(a, b & C) of the notification issued vide No. DTP/MUN-20/2009-10/477-90 dated 8th July, 2015. The Executive Engineer(s) shall also follow the process of payment authorisation as per order issued by the finance department vide No. (a) BT-445/2015/422 dated 15th May, 2015 and (b) BT-608/2016/1366 dated 22nd August, 2016. The accounts and other Report Return towards monthly, quarterly and annually also to be submitted to the concerned authority by the Executive Engineer(s) against each project(s)/work(s) from time to time.

This issues with the approval of the competent authority vide U.O. Nos. (a) 134 dated 31st January, 2018 of the Secretary (UD, Housing and Town Planning, (b) 61 dated 2nd February, 2018 of the Parl.
