The pensionary benefit for the period of his service till the date of his absorption in the Department of Education shall be Governed by the CCS (Pension Rules 1972) as amended up to date.

The incumbent officer is entitled to hold lien period of 2(two) year in his parent cadre Department i.e., RWD.

The other terms and conditions which are not specified herein, shall be governed by the existing Government rules and orders in force from time to time.
