**ARUNACHAL PRADESH ECO-TOURISM POLICY**

**1. Preamble :**

Arunachal Pradesh, the land of Dawn situated between latitudes 26° 30'N and 29° 30'N, longitudes 91° 30'E and 97° 30'E with a geographical area of 83,743 sq.km is the largest State in North East India and is bounded by Bhutan to the west, China to the north-east, Myanmar (Burma) to the east and the plains of Assam to the south. The state lies in the eastern part of the majestic Himalaya mountain range and is identified as a globally important region for biodiversity. Due to varied climatic conditions and altitudes the state supports rich vegetation and wildlife with unique ecosystems ranging from tropical forests to alpine meadows to snow clad mountains. With 80% of its geographical area under forest cover, the state is custodian to over 5000 flowering plants, 200 mammals, 850 birds and 79 reptiles. The cultural diversity of Arunachal Pradesh is also unique and of immense importance as the state is the home of 26 major tribes and 110 sub-tribes with a rich culture closely linked with nature. Arunachal Pradesh is acknowledged to be one of the most splendid, variegated and multilingual areas of the world.

The local indigenous communities of Arunachal Pradesh, until a few decades ago lived more or less in isolation due to geographical barriers formed by hills, mountains and mighty rivers. Based on available diverse natural resources in the area under their jurisdiction, their traditional lifestyle flourished with innovation and rich knowledge system encompassing natural resource management, agriculture and animal husbandry techniques as well as sound community governance institutions.

However, with enhanced communication, mainstream development programmes and schemes, 'modern' education and, a plethora of externally driven laws, policies and rules and governance structures; rapid transition has cascaded in every walk of life. This change as perhaps elsewhere in the world has been a mixed bag of positive and negative drivers seeping in the family, community structures and society at large. The growing socio-economic inequity has taken a due toll on the erstwhile harmonious relationship with earth and depletion of diverse natural resources of the state is increasing rapidly. It is therefore important to promote development models for the state which combine livelihood development that is more inclusive and at the same time promotes conservation of natural resources.

Tourism is the world's largest and fastest sector of global economy and within the tourism sector, one of the most rapidly growing areas is that of ecotourism. Ecotourism is defined as "responsible travel to natural areas that conserves the environment and improves the well-being of local people" (TIES, 1990). Promoting ecotourism in Arunachal Pradesh as opposed to the conventional model of mass tourism will have many advantages for the state. It will help conserve and promote the state's rich natural and cultural heritage, it will reduce negative impacts of mass tourism and will have lower infrastructure costs, it will help diversify and spread income generation to the village level, and will create a niche for Arunachal Pradesh globally and nationally as a centre for community-based ecotourism.

Considering the rapid increasing trend of tourists coming to the state, from 2,178 in 1999 to 2,31,252 in the year 2010, it is necessary to formulate an ecotourism policy for the state which will enhance livelihoods for the local communities while ensuring conservation of rich natural and cultural heritage of the state. The policy will help to promote, guide and regulate tourism in a manner that benefits the local communities without compromising the ecological well being of the state.

**2. Policy Vision :**

To develop Arunachal Pradesh as premier national and global ecotourism destination providing a unique and memorable wilderness and cultural experience to visitors while enhancing the economic well being of local communities and securing the natural and cultural values and viewed as tool for sustainable development of the state.

**3. Policy Objectives**

- 3.1 Ensure conservation of the existing biodiversity, ecosystems and religious monuments/Sacred grooves of the state as well as people's culture and tradition.
- 3.2 Generate awareness among local communities to increase their pride and appreciation for local natural and cultural values.
- 3.3. Ensure active involvement of the local and indigenous communities in ecotourism planning, development and implementation.
- 3.4 Identify and promote ecotourism sites within and outside protected areas by diversification of a range of ecotourism activities.
- 3.5. Develop standards and norms Ecotourism Certification specific for the state.
- 3.6. Guide the development of permissible and ecologically sound ecotourism infrastructure.
- 3.7. Enunciate a mechanism to establish partnerships between all stakeholders to develop and promote ecotourism.
- 3.8. Build capacity of all stakeholders in natural and cultural heritage interpretation, hospitality, business and communication skills to successfully and sustainably manage ecotourism.
- 3.9. Enable the development of a sustained and effective marketing strategy and plan.

**With the ultimate Goal of :**

- (a) Conserving the natural and cultural diversity of the state.
- (b) Promoting Arunachal Pradesh as the premier ecotourism destination.
- (c) Securing economic benefits for the local communities without adversely affecting their cultural ethos or ecological security.

**4. Guiding Principles :**

The guiding principles for promotion of ecotourism in Arunachal Pradesh will be as follows :

**Principle 1 : Local culture and nature focused :** Visitors would have the opportunity to experience local cultures and natural diversity without disturbing their existence.

**Principle 2 : Community based :** In all cases, active participation of local communities in planning and managing ecotourism related activities would be ensured.

**Principle 3 : Enhanced visitor experience :** Visitors would leave with an enhanced experience of ecotourism and community based tourism.

**Principle 4 : Conservation of cultural and biological diversity:** All ecotourism activities would contribute to the conservation of biodiversity and cultural diversity of the state.

**Principle 5 : Benefits to local communities :** Direct benefits to local communities from ecotourism related activities and equitable benefit sharing among community members would be ensured.

**Principle 6 : Low impact tourism :** Negative impacts of tourism on the state's rich biological and cultural diversity would be minimized by providing a code of conduct for all stakeholders and limiting tourist numbers in sensitive areas by developing transparent system of rules and monitoring mechanism.

**Principle 7 : Multi-stakeholder convergence :** Collaboration and cooperation between local communities, tour operators, government departments and other key players in the development and promotion of ecotourism in the state would be enabled.

**5. Implementation Strategies :**

Arunachal Pradesh Ecotourism Development Society will be constituted to oversee and implement this policy. The Society shall be assisted by Forest Department, Tourism Department and other Government Departments in implementation of the Ecotourism Policy and strategies. The Society shall be equipped with the required technical and financial resources to implement the policy. The Society will coordinate with local, national and international stakeholders for planning, developing and implementing projects compatible to the policy.

**Strategy 5.1 : Identification of potential ecotourism sites :**

- 5.1.1. Within each approved Tourist Circuit, sites with potential attractions to promote as ecotourism activities will be selected.
- 5.1.2. For promotion of sites within Protected Areas, identification of ecotourism zone as per applicable guidelines will have to be first demarcated.
- 5.1.3. Possible activities/attractions for visitors in identified sites will be listed for the promotion. Some of activities/attractions that could be promoted are :
  - (a) Special Interest Nature Trails (Bird watching, medicinal plants,
  - (b) Flowering plants, caving, butterfly tour, bamboo etc.)Forest walks
  - (c) Visits to religious and culturally important monuments and sites
  - (d) Experiencing traditional village activities and life style
  - (e) Village walks
  - (f) Wildlife viewing
  - (g) Hiking to alpine meadows, lakes and peaks
  - (h) Traditional cultural programs and local festivals
  - (i) River rafting
  - (j) Angling
  - (k) Agro tourism

**Strategy 5. 2 : Development of infrastructure :**

- 5.2.1. Take up projects for development or improvement of infrastructure as required in the identified sites as per the approved ecotourism guidelines.
- 5.2.2. For the identified and approved Tourist Circuits 'Infrastructure Zonation' will be carried out to ensure direct benefit to community and broadly there will be two categories of Infrastructure Zones –
  - (i) Urban Centers where construction of Hotels, Lodges and Guest Houses managed by individual entrepreneurs or business groups or government will be allowed as per ecotourism guideline.
  - (ii) Villages where only community based tourism infrastructures to be managed by village level Ecotourism Management Committee will be allowed as per ecotourism guideline.
- 5.2.3. Broad categories of infrastructure to be developed in the villages, which will vary from place to place could be:
  - (a) Village Campsites
  - (b) Trekking Campsites
  - (c) Trekkers Huts
  - (d) Home Stays
  - (e) Eco-lodges
  - (f) Interpretation Centers
  - (g) Signage
  - (h) Trekking routes/trails
  - (i) Observation towers/hides
  - (j) Camping equipment
- 5.2.4. Locally available resources should be utilized for developing permanent infrastructure and as far as possible traditional designs and architecture should be used.
- 5.2.5. Wherever possible, renewable energy should be used.

**Strategy 5.3: Capacity building of service providers :**

- 5.3.1. Establish a centre of excellence for responsible tourism to build capacity of local communities, tour operators, government staffs who are directly involved in promotion of ecotourism in the state.
- 5.3.2. Organize training courses/refresher courses for communities engaged in promotion of ecotourism on specific themes such as conservation, home stay management, hygiene, waste management, cooking, camp site management guiding and interpretation, communication skills and business management on regular basis.
- 5.3.3. Organize capacity building programs for tour operators, NGOs and frontline staff of Forest and Tourism Departments.
- 5.3.4. Generate awareness for promotion of best practices guidelines, codes, standards, accreditation schemes and models concerned with aspects of ecotourism.
- 5.3.5. Identify low season income generation activities to complement ecotourism such as handicraft development, food and fruit processing, repairing and maintenance of various infrastructures.
- 5.3.6. Facilitate cross site visits within and outside the state for experience sharing and enhance learning.

**Strategy 5.4 : Participation of local communities :**

- 5.4.1. Village level Ecotourism Management Committees/existing village level Committee (EDC, BMC, VFMC, VDC etc.) to be constituted/strengthened will be in the forefront to manage the entire tourism infrastructure and to provide service to visitors by involving trained local villagers on rotation basis.
- 5.4.2. Various tourism infrastructures required for promotion of ecotourism will be provided by APEDS through the Committees in each site as support or on lease, not directly to any individual.
- 5.4.3. Income generation opportunities for villagers from ecotourism services could include:
  - (a) Home Stay Operator
  - (b) Cook and cook helper
  - (c) Guide

- (d) Porter
  - (e) Pack animal provider
  - (f) Performing cultural program
  - (g) Camp Manager
  - (h) Marketing food items
  - (i) Marketing local handicrafts and souvenirs – sharing knowledge and skills with the visitors
  - (j) Teaching agricultural techniques and guiding the learning experience
  - (k) Conservation Volunteer
- 5.4.3. Income opportunities for Ecotourism Management Committees/existing village level committees (EDC, BMC, VFMC, VDC etc.) to develop their corpus will be from
- (a) Village Camp Site charges
  - (b) Trekking Camp, Eco-lodge and Trekkers Hut charges
  - (c) Hiring charge for Camping Materials during trekking by visitors.
  - (d) Interpretation Centre entry charges
  - (e) Entry fee and Management/Conservation Fee approved by APEDS for trekking in areas under their jurisdiction outside protected areas
- 5.4.4. Visitors will pay directly to the Committees as per the rate approved by APEDS which will be then handed over the individual villagers who were involved by committee for services.
- 5.4.5. The Committee will maintain proper accounts and will do annual reporting and auditing of income and expenditure from ecotourism.

**Strategy 5.5 : Linkages with key stakeholders :**

- 5.5.1. Establish partnerships with local key stakeholders to develop and promote ecotourism business as per approved guidelines in the state.
- 5.5.2. Establish partnerships with tour operators, experts and institutions at national and international level for promotion of ecotourism.
- 5.5.3. Organize regular seminars and workshops to discuss and deliberate on ecotourism achievements with key stakeholders and for feed back to improve quality of facilities and services.
- 5.5.4. Hold annual meetings of Coordination Committees, village level Ecotourism Management Committees and government officials in each approved tourist circuit for assessment of achievement and impact of ecotourism being promoted.

**Strategy 5.6 : Promotion, marketing and publicity :**

- 5.5.1. Branding of state with tag line and brand ambassador for promotion of ecotourism.
- 5.5.2. Create a marketing cell within APEDS which work in coordination with tour operators, village level committees for ecotourism marketing.
- 5.5.3. Participate in national and international tourism seminars, MARTS, conference, exhibitions, etc.
- 5.5.4. Develop appropriate packaging and branding of ecotourism destinations.
- 5.5.5. A website will be established by competent authority to promote and coordinate the marketing of ecotourism which will also have direct link between service providers and the visitors with provision of online booking and payment mechanism.
- 5.5.6. Tie up with travel TV programs, magazines, travel books etc. for promotion and marketing.
- 5.5.7. Establish linkages with tourist offices of Government India abroad, international and national travel agents.
- 5.5.8. Develop brochures, posters, short films, etc. for marketing and promotion.
- 5.5.9. Plan transparent pricing system for the visitors and service providers.
- 5.5.10. Promotion of Ecotourism Circuit organization of Annual Fix date Ecotourism Festival.
- 5.5.11. Develop site based educational and interpretation materials for all stakeholders.

**Strategy 5.7 : Research and Monitoring :**

- 5.7.1. Regular monitoring is mandated to understand visitors' impact on the environment and local communities.
- 5.7.2. Research is required to be carried out to generate new knowledge, insights and modalities for sustainable ecotourism.
- 5.7.3. Mechanism for feedback from the visitors with option in website and also handing over a feedback form to visitors along with RAP/ILP which can be deposited in various check gates and nearest tourism and forest department offices after the completion of tour.

**Strategy 5.8 : Safety and Security :**


- 5.8.1. Develop linkage of tour operators and travel agents with an authorized Insurance Agency to have insurance for the clients to cover the risk of accidents and injuries during the trip.
- 5.8.2. Ensure insurance of service providers including camp managers, porters, guides and cooks to cover risk of any accident and injuries during their trip with visitors.
- 5.8.3. Organize training workshops for guides and camp managers on risk management, first aid, rescue operations.

**6. Institutional Mechanism :**

In Arunachal Pradesh more than 60% of the total forest area is under the traditional control of local indigenous communities and nearly 40% under the administrative jurisdiction of the State Forest Department. Thus, unlike many of the ecotourism sites in India which are either within Protected Areas or in areas under the jurisdiction of the state Forest Departments, in Arunachal Pradesh a significant number of potential ecotourism sites are in areas where local indigenous communities have traditional ownership and user rights. This provides a unique opportunity to promote ecotourism as viable conservation incentive to the secure economic and ecological security of local communities of the state.

An 'Arunachal Pradesh Ecotourism Development Society' (APEDS) will be constituted with the mandate to promote and regulate ecotourism in areas within and outside Protected Areas of the state and will work in close coordination with the Department of Environment and Forest and the Department of Tourism.

An **Arunachal Pradesh Ecotourism Development Society** (hereinafter referred as the 'Society') will have it's Headquarters at Itanagar (office site to be decided in consultation). The Society will have a General Body for overall policy guidance and direction and an Executive Body for the promotion and regulation of ecotourism in the state. For every approved Tourist Circuit of the state, Coordination Committees will be constituted who will work with APEDS for the circuit specific promotion of ecotourism. Village level Ecotourism Management Committees and Eco-development Committees will be constituted which will work under the guidance of the Coordination Committees and APEDS to provide services to visitors and manage the facilities established for promotion of ecotourism.



### 6.1. Functions of the Society :

The Society will provide a platform for stakeholders to work towards the development of ecotourism in the state and, through the Coordination Committees and village level Ecotourism Management Committees, will have the following functions :

- 6.1.1. Identification of potential ecotourism sites in each approved Tourist Circuit of the state both within and outside Protected Areas.
- 6.1.2. Develop site specific Action Plans for the circuits in consultation with key stakeholders and based on global ecotourism models and guidelines.
- 6.1.3. Develop ecotourism facilities like Interpretation Centers, Trekking Trails, Camping Grounds, Village Camp Sites, Home Stays, Trekkers Huts, Dormitories, etc. based on the Action Plans.
- 6.1.4. Develop the capacity of local villagers to extend world class service to visitors and manage various ecotourism facilities for their economic development.
- 6.1.5. Facilitate development and revision of policies and guidelines for promotion of ecotourism for the state government in consultation with key stakeholders.
- 6.1.6. Assist the state government to develop rules, regulations, guidelines, rates of services, etc. in consultation with key stakeholders.
- 6.1.7. Monitor quality of services and facilities offered to visitors to ensure implementation of the ecotourism in the state as per approved guidelines and assists concerned departments with enforcement of regulations.
- 6.1.8. Assist Department of Environment and Forest and Department of Tourism to take appropriate action to minimize the negative impact of tourism on biodiversity and cultural diversity in the ecotourism sites.
- 6.1.9. Develop project proposals for funding from State Government, Central Government and other agencies to carry out various activities for the promotion of ecotourism in the state.
- 6.1.10. Develop different types of publicity and outreach materials (posters, brochures, website, signage etc.) and establish links with national and international tour operators for marketing of ecotourism products of the state.

### 6.2. Role of the Governing Body of the Society :

- 6.2.1. Formulate rules and regulations of the Society as required for promotion of ecotourism in the state.
- 6.2.2. Monitor the annual budget and annual activity plan of the Society.
- 6.2.3. Supervise the work of Executive Committee.
- 6.2.4. Create new posts for the Society as when required as per approved budget.
- 6.2.5. Facilitate periodic organization of multi-stakeholder consultation on scope of improving ecotourism service and facilities in the state.

The **Executive Body** of the Society will be constituted of following members :

### 6.3. Role of Executive Body :

- 6.3.1. Approval of annual work plan of the Society.
- 6.3.2. Approval of the projects for ecotourism development.
- 6.3.3. Preparation of the annual budget, audit reports, annual reports and other relevant proposals and getting them approved by the General Body.
- 6.3.4. Submission of the amendments in the rules for the approval of the General Body.
- 6.3.5. Submission of proposals for various levies on tourists to the General Body for approval and after approval, apply these at the ecotourism sites.
- 6.3.6. Monitor and evaluate the implementation of rules and regulations approved for ecotourism in the sites.
- 6.3.7. Coordinate with key stakeholders for suggestions and feedback to improve the ecotourism facilities and service of the state.
- 6.3.8. Organise training workshops and awareness programs for all the key stakeholders.
- 6.3.9. Establish national and international linkages for marketing of ecotourism products of the state.

### 6.4. Officials of the Society :

- 6.4.1. The (To be decided in consultation) of the state shall be the ex-officio Chief Executive Officer of the Society.
- 6.4.2. The Society will have two Divisions based at the Office of the Society and will work in close coordination for promotion of ecotourism in the state.
  - (a) **Division - I** – Headed by senior Officer from Forest Department on deputation to promote ecotourism in Protected Areas of the state and also enforcement of wildlife related rules and regulations in ecotourism sites outside Protected Areas.
  - (b) **Division - II** – Headed by senior Officer from Tourism Department on deputation for promotion of ecotourism in areas outside Protected Areas of state.
- 6.4.3. Supporting staff will be appointed either on deputation or new recruitment as per approved budget and as per the Government of Arunachal Pradesh employment rules.

### 7.1. Maintenance of Accounts :

Arunachal Pradesh Ecotourism Development Society (APEDS) to be constituted, will have the mandate to promote and regulate eco-tourism in areas within and outside Protected Areas of the state and will work in close coordination with the department of Environment and Forests and the department of Tourism. The society will have a **General Body** for overall policy guidance and direction and an **Executive Body** for the promotion and regulation of ecotourism in the State. For every approved tourist circuit of the state, **Coordination Committees** will be constituted for the circuit specific promotion of Eco-Tourism. **Village level Ecotourism management Committee** and **Ecodevelopment Committee** will be constituted which will work under the guidance of the coordination committees and APEDS to provide services to visitors and manage the facilities established for promotion of eco-tourism. The Executive Body drawing its personnel from both Tourism department and Department of Environment & Forests, will be responsible for implementation and regulation. The principal Chief Conservator of Forests (Wildlife & Biodiversity) and Chief Wildlife Warden will work as Chief Executive Officer/Member Secretary of the society who will functionary of the society, CEO will maintain the accounts of the society.

### 7.2. Funding source of the Society :

The goal of the Arunachal Pradesh Ecotourism is to conserve the natural and cultural diversity of the state, promote Arunachal Pradesh as the premier eco-tourism destination and secure economic benefits for the local communities without adversely affecting their cultural ethos or ecological security.

The society and its organs (General Body, Executive Body, Chief Executive Officer, Coordination Committees, Village level Ecotourism Management Committee, etc.) are to be parts of the Government of Arunachal Pradesh. Therefore, to promote eco-tourism in the state, funding arrangements will be made by the Government of Arunachal Pradesh. The government, in addition to its own resources, shall explore potential funding sources from

- Ministry of Tourism, Government of India
- ITDC
- Tour Operator guilds, etc.

**Any other :**

The society may develop mechanism/strategies for finances as follows:-

- (a) Provide financial support to encourage people to take part in new ecotourism ventures
- (b) Provide small scale funding to community groups that want to engage in village based ecotourism activities via grants from the government.
- (c) Encourage banks to provide loans at reasonable interest to local people who wish to engage in ecotourism activities
- (d) Develop SHGs or women saving and credit groups for consumptive and productive loans and connecting it with rural development banks for additional funding.
- (e) Create awareness in people for generating finance from new eco-tourism activities.
- (f) Develop long term plan for ecotourism marketing activities in the state. This plan will combine several potential approaches, such as direct government allocation, creating new hotels taxes, establishing wider tourism tax, collecting membership fee in the tourist sector and private sector sponsorship.

2. Till the process of preparing Aerodrome/Heliport Manual & Safety Manual is completed by the Department of Civil Aviation, Government of Arunachal Pradesh the concerned Chief Aerodrome Security Officers (column-3 of Annexure-I) are required to prepare an Aerodrome/Heliport security Programme and get the airports/heliports security approval by Bureau of Civil Aviation security (BCAS) which shall be subject to survey of security manpower and other fire safety & security arrangements by standing committee of BCAS. No. PERS-86/2010 (Vol-I).—WHEREAS, vide Government order No. PERS -86/2010 (Vol-I), dated 14th February, 2018, Shri Nyali Ete, APCS (AG) was placed under suspension with effect from 14th February, 2018 on account of the matter regarding illegal registration of 935 Tourist Vehicles as Sleeper Coach buses by the District Transport Officers of Arunachal Pradesh Viz ; (DTO, Itanagar Capital Complex-494, DTO Yupia - 311, DTO Tezu - 79, DTO Namsai - 37 and DTO Bomdila - 14) followed by issue of all India Permits by the Secretary, State Transport Authority, Naharlagun to operate in other States was examined by the Vigilance Department and the Competent authority vide his Order dated 21st December, 2017 had directed to place the then Secretary, State Transport Authority, the Director (Transport) and other officers under suspension with immediate effect since criminal proceedings is contemplated against them ;

AND WHEREAS, the matter pertaining to his suspension was discussed and deliberated in the meeting of Suspension Review Committee headed by Chief Secretary.

AND WHEREAS, the Vigilance Department is contemplating criminal proceedings against Shri Nyali Ete, APCS and therefore revocation of his suspension order will have detrimental and demoralizing effect on all the fellow officers and will set a bad precedence in Government functioning ;

AND WHEREAS, after detailed deliberations and taking into consideration all the facts and circumstances of the case, the serious charges leveled against the said officer who has indulged in gross misconduct and has acted in total violation of prescribed legal provisions and the fact that criminal proceedings have also been contemplated against him, the Suspension Review Committee held on 11th May, 2018 recommended that the suspension of Shri Nyali Ete, APCS be extended for a further period of 180 days with effect from 14th May, 2018.

Grade), for a further period of 180 days with effect from 14th May, 2018.

It is further ordered that during the period that this order shall remain in force, the headquarters of Shri Nyali Ete, APCS (Admn Grade), shall be "ITANAGAR" and shall not leave the headquarters without obtaining the prior permission of the undersigned.
