NOTIFICATION

The 14th November, 2017

No. AP/KVIB/452/2012-13.—In exercise of the powers conferred by the provision in Articles read with the Arunachal Pradesh Khadi & Village Industries Board, 1989 (amended up to 1998), Section 33 (2) (a) and the Arunachal Pradesh Khadi & Village Industries Board Regulations, 1998, Clause 3 (4) and 3 (13), the Governor of Arunachal Pradesh hereby pleased to make the following rules to regulate method of recruitment to the post of Chief Executive Officer in the Arunachal Pradesh Khadi & Village Industries Board (APKVIB), a statutory body of the Government of Arunachal Pradesh under the Department of Industries, namely :-

1. **Short title and commencement** : (1) These rules may be called the “**Chief Executive Officer (Group - A) Recruitment Rules, 2017**”.

(2) They shall come into force on the date of their notification in the Arunachal Pradesh Gazette.

2. **Number of posts, classification and scale of pay** : The number of the posts, their classification and the scale of pay (Pay Band and Grade Pay) therein shall be as specified in columns 2 to 4 of the aforesaid Schedule.

3. **Methods of recruitment, age limit and other qualifications etc** : The methods of recruitment to the said posts, age limit, qualification and other matters relating thereto shall be specified in columns 5 to 14 of the aforesaid schedule.

4. **Disqualification** : No person,—

(a) who has entered into a contracted marriage with a person having a spouse living ;

(b) who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the post :

Provided that the Governor of Arunachal Pradesh may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of these rules.

5. **Power to relax** : Where the Governor of Arunachal Pradesh is of opinion that it is necessary or expedient so to do, he may, by order for reasons to be recorded in writing, and in recommendation/consultation with the Arunachal Pradesh Khadi & Village Industries Board/Arunachal Pradesh Selection Board/Public Service Commission, relax any of the provisions of these rules with respect to any class or category of person.

6. **Saving** : Nothing in these rules shall affect reservation/relaxation of age limit and other concessions required to be provided for the Scheduled Caste/Scheduled Tribes and other special categories of persons in accordance with the order issued by the State/Central Government from time to time in this regard.
