**Terms and Conditions :—**

1. The appointees shall be on probation for a period of 03 (three) years as per APHS Rules, 2000, under Section 10 (1) from the date of their joining. Appointment will be confirmed only after satisfactory completion of the probation period.
2. The appointee should report for his/her duties at his/her respective place of posting within one month from the date of issue of this order, failing which it will be presumed that he/se is not willing to join the post and accordingly the appointment will stand cancelled.
3. The appointee shall serve in rural areas compulsorily for a minimum period of 5 years in any part of Arunachal Pradesh, during the initial part of their service as per Govt. order.
4. If any declaration given or information furnished by the candidate proves to be false or if the candidate is found to have willfully suppressed any material/information, he /she shall be liable for removal from service and such other action as Govt. deem fit and proper.
5. The appointee may be terminated at any time by one-month notice given by either side viz. the appointee or the appointing authority, without assigning any reason. The appointing authority shall however reserves the right to terminate the service of the appointee forthwith or before the notice by making payment to him/her of a sum equivalent to the pay and allowances for the period of notice or the unexpired portion thereof.
6. Appointment is subject to production of a certificate of fitness from the Medical Board appointed/ authorized by the Govt. of Arunachal Pradesh.
7. No request for change of place of posting will entertained.
8. Private practices of any kind whatsoever including laboratory and consultant practice are prohibited as per section 10 of sub-section 13 of the APHSR-2000.
9. No TA/DA will be allowed while joining on 1st appointment.
10. The seniority shall be counted as per the merit list.
11. Condition mentioned in the offer of appointment will also apply.

**CORRIGENDUM**

The 31st August, 2018

No. LM/DRJ-83/2016-17 (Part-III).— In pursuance of letter vide No. AC/DAPORIJO/ACQ/A/VOL- V/58 of dated 10th July, 2018, submitted by the Defence Estate Officer, Itanagar, Circle. The preliminary notification issued under section 11 (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, for acquisition of land in Upper Subansiri District in general area at Boraropuk-I, II and I (A) land measuring = 341.882 acres and subsequently approved by the Govt. of Arunachal Pradesh vide letter No. LR-13/92 of dated 18th January 2018, in the notification it was not mentioned that :-

- (i) **The provision of Chapter II and III and Section 15 to 18 of the Act shall not apply to the acquisition and declaration may be made under Section 19 in respect of Boraropuk Land at any time after the date of publication of preliminary notification under Sub-Section (1) Section 11 and ;**
- (ii) **That no additional compensation will be paid by the Deputy Commissioner as per the proviso to the sub-section (5) of Section 40, since the President of India is satisfied the land proposed to be acquired is for Accretional Forces affects the Sovereignty and integrity of India and the Security and Strategic interest of India.**

As the Government of India has invoked and accorded the Urgency clause Section 40 of LARR Act, 2013 vide letter No 124/US (L)/2017 of dated 19th September 2017.

Therefore, this corrigendum is issued for all the stake holders for information and to take notice of the above provision and it may be assumed that the above provision has been inserted as the part of the Preliminary Notification issued under Section 11 (1) of the LARR Act, 2013 vide letter No. LR-13/92 of dated 18th January, 2018.
