## ORDER

The 8th October, 2018

No. PERS-86/2010(Vol-I)/253.— WHEREAS, vide Government order No. PERS/86/2010(Vol-I), dated 14th February, 2018, Shri Nyali Ete, APCS (AG) was placed under suspension with effect from 14th February, 2018 on account of the matter regarding illegal registration of 935 Tourist Vehicles as Sleeper Coach buses by the District Transport Officers of Arunachal Pradesh Viz ; (DTO, Itanagar Capital Complex - 494, DTO Yupia-311, DTO, Tezu - 79, DTO Namsai - 37 and DTO Bomdila - 14) followed by issue of all India Permits by the Secretary, State Transport Authority, Naharlagun to operate in other states was examined by the Vigilance Department and the Competent authority, vide his order dated 21st December, 2017 had directed to place the then Secretary, State Transport Authority, the Director (Transport) and other officers under suspension with immediate effect since criminal proceedings is contemplated against them ;

AND WHEREAS, Vide Government order of even number dated 12th May,2018, the suspension of Shri Nyali Ete, APCS (Admin. Grade) under suspension was extended for a further period of 180 days with effect from 14th May, 2018 to 9th November, 2018,

AND WHEREAS, the matter pertaining to his suspension was discussed and deliberated in the meeting of Suspension Review Committee headed by Chief Secretary.

AND WHEREAS, the Vigilance Department is contemplating criminal proceedings against Shri Nyali Ete, APCS and therefore revocation of his suspension order will have detrimental and demoralizing effect on all the fellow officers and will set a bad precedence in Government functioning ;

AND WHEREAS, after considering the facts and circumstances of the case and after detailed deliberations, the SRC held on 8th October, 2018 recommended that the suspension of Shri Nyali Ete, APCS be extended for a further period of 180 days with effect from 10th November, 2018 ;

AND WHEREAS, the Compentent Authority after due examination of all the facts circumstances of the case and documents placed on record has accepted the aforementioned recommendation of the Suspension Review Committee ;

NOW THEREFORE, the Governor of Arunachal Pradesh, in exercise of powers conferred by the Rule 10(6) of the CCS (Classification, Control and Appeal) Rules 1965, hereby extends the Suspension of said Shri Nyali Ete, APCS(Admn. Grade), for a further period of 180 days with effect from 10th November, 2018.

It is further ordered that during the period that this order shall remain in force, the headquarters of Shri Nyali Ete, APCS (Admn. Grade), shall be "ITANAGAR" and shall not leave the headquarters without obtaining the prior permission of the undersigned.
