**NOTICE INVITING EXPRESSION OF INTEREST (EOI)**

The Deputy Commissioner-cum-Principal Census Officer, East Siang District, Government of Arunachal Pradesh, invites sealed Expressions of Interest (EOI) from eligible and experienced firms, consultants or agencies for the **Outsourcing of Manpower** to support the National Population Census 2027. This engagement aims to ensure the smooth and timely conduct of census operations within the district by providing qualified technical and support staff.

1. **Objective:** The proposed assignment aims to provide high-quality manpower to assist the District Administration in data management, technical troubleshooting and administrative support during the various phases of the **National Population Census 2027**, including House Listing and Population Enumeration.
2. **Scope of Work:** The selected agency will be responsible for providing the following manpower:
  - **Technical Assistants- 10 (Ten) No.s**
    - **Qualification:** Graduate in any discipline with a Diploma in Computer Applications (minimum 6 months course duration).
    - **Wages:** Rs. 25,000 (Twenty-Five thousand) per month.
    - **Key duties:** Extensive use of mobile application, web application and CMMS portal for data collection and any other similar census related work as and when required.
  - **Multi- Tasking Staff (MTS) – 1(One) No.**
    - **Qualification:** Class X pass from a recognised board.
    - **Wages:** Rs. 18,000 (Eighteen thousand) per month.
    - **Key Duties:** General office support, movement of census materials and assisting in basic administrative tasks.
3. **Eligibility Criteria:**
  - Agencies must have proven experience in providing manpower to Government/Semi- Government organizations.
  - The agency must demonstrate the capability to source candidates with adequate proficiency relevant to the assigned duties.
  - Possession of valid registration documents, including GST and statutory labour law.

4. **Submission of EOI:** Interested agencies are requested to submit their Expression of Interest along with the following documents:

- Organizational profile and details of relevant experience in manpower outsourcing.
- Technical capability statement and list of available resources.
- Supporting registration and statutory documents.

The EOI, complete in all respects, shall be submitted in a sealed cover to the undersigned on or before 1700 hours of 05/03/2026. The envelope should be super scribed as "EOI for Outsourcing of Manpower for Population Census 2027". - Detailed Request for Proposal (RFP) and final terms shall be issued separately to shortlisted agencies.


