**ADVERTISEMENT FOR SELECTION OF CHAIRMAN OF APSERC**

In accordance with Section 84, 85, & 89 of the Indian Electricity Act, 2003, the Government of Arunachal Pradesh invites application from Indian citizens for the post of Chairperson of the single member Arunachal Pradesh State Electricity Regulatory Commission from the persons who meet the following criteria.

1. The person shall be of ability, integrity and standing who has adequate discerning knowledge and experience of and has shown capacity in dealing with problem relating to engineering finance, commerce, economics, law or management.
2. The person should not have any financial or other interest with any corporate entity dealing with generation, transmission, trading and distribution of electricity in Arunachal Pradesh which is likely to affect prejudicially his or her function as chairperson of the Commission. The person must give a certificate to this effect which applying for this post.
3. The Chairperson shall hold office term of five years from the date he enters upon his office or till he attains the age of Sixty five (65) years, whichever is earlier, but shall not be eligible for re-appointment in the same capacity in APSERC.
4. The Chairman shall receive a pay in the pay Band HAG+ Scale (Rs.75,000-80,000/-) pm with other allowances as admissible to the post in the state belonging to All India Services Cadre and other terms and conditions shall be as prescribed in the Arunachal Pradesh State Electricity Regulatory Commission (Salary, Allowances and other conditions of Service of Chairman) rules, 2010.
5. Other terms of appointment shall be governed by the provisions of Indian Electricity Act 2003.
6. The person appointed would have to resign or opt for voluntary retirement from the services to which he/she belongs.
7. Suitable candidates with adequate qualifications and requisite age as prescribed above may apply with their Bio-Data mentioning their age, qualifications, experience, present status etc. as per the enclosed format latest by 20<sup>th</sup> March, 2020 to "The Commissioner ( Power) Government of Arunachal Pradesh, and sent at the following address " Arunachal Pradesh State Electricity Regulatory Commission (APSERC), Niti Vihar,.T.T Marg., Opposite General Manager (HPDCAPL) Office, Itanagar-791111, Arunachal Pradesh" with the envelope super scribed "Application for the post of Chairperson, APSERC".
