



In pursuance to the Govt. of India, Ministry of Personnel, Public Grievances & Pensions' OM No.42/07/2021-P&PW(D) Dated: 22<sup>nd</sup> July'2021 (copy enclosed) on the subject mentioned above, the Governor of Arunachal Pradesh is pleased to order that the Dearness Relief (DR) payable to State Government Pensioners/Family Pensioners shall be increased by 11% from the existing rate of 17% to 28% with effect from 1<sup>st</sup> July, 2021 RPT from 1<sup>st</sup> July'2021..

All other terms and conditions as enunciated in the Govt. of India, Ministry of Personnel, Public Grievances & Pensions' OM No.42/07/2021-P&PW(D) Dated 22<sup>nd</sup> July'2021 shall remain unchanged.
